Dacca, the 1st January 1976.

No. S.R.O.2-L/76.—In exercise of the powers conferred by the sub-section (5) of section 15D of the Income-tax Act, 1922 (Act XI of 1922), the National Board of Revenue is pleased to approve the Marine Academy, Chittagong, for purposes of that section subject to the following conditions:—

- (a) that the accounts of the Fund shall be fully audited by a Chartered Accountant every year;
- (b) that such audited accounts shall be submitted to the Income-tax Officer in whose territorial jurisdiction the head office of the Fund is situated;

- (c) that in the event of dissolution of the Fund its assets left after meeting its liabilities, if any, shall be transferred to another institution or fund approved under section 15D of the Income-tax Act, 1922; and
- (d) that the Fund shall not make any donation or grants to any other charitable institution or fund unless it is an institution or fund approved under section 15D of the Income-tax Act, 1922.
