No. S. R. O. 12-L/83/84-Excise. In exercise of the powers conferred by the provisions of column 3 of the First Schedule to the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to make the following further amendments in this Division's Notification No. S. R. O. 203-L/81/41-Excise, dated the 6th June 1981, namely :-

In the aforesaid Notification, in item 02. 04 (II) (2) (i) (a) in column I, for entry (vi) in column 2 and the entries relating thereto in column 3, the following shall be substituted, namely :-

- (vi) (a) exceeds take one and fifty poisha but does not exceed taka two and twenty-five poisha.
- Taka ninety plus seventy-five per cent, of the retail price in excess of taka one hundred and fifty per thousand cigarettes.
- (b) exceeds taka two and twenty- Taka ninety-five plus seventy-five ceed taka three.

five poisha but does not ex- per cent, of the retail price in excess of taka one hundred and fifty per thousand cigarettes.
