No. S.R.O. 15-L/75/13-Sec (II).—In exercise of the powers conferred by section 17 of the Arms Act, 1878 (Act No. XI of 1878), the Government is pleased to make the following further amendments in the Arms Rules, 1924, namely:—

In the rules aforesaid, in Schedule VIII, in Form XVI, for paragraph I, the following paragraphs shall be substituted, namely:—

"I. The fees payable in respect of the initial grant and each subsequent renewal of licences in this Form shall be at the following annual rates, nan ely:—

Nature of weapon. For initial grant. For each renewal

1. Breach loading pistol, revolver or rifle Taka 40.00 Taka 20.00

2. Breach loading shotgun Taka 20.00 Taka 10.00

3. Any weapon other than a breach loading Taka 4.00 Taka 2.00

II. A fee of Tk. 2.00 shall be charged in respect of licences granted for ammunition of the kind as referred to in clause (ii) of the proviso to sub-rule (I) of rule 33".

Now, therefore, in exercise of the powers conferred by sub-rule (1) of rule 15 of the Emergency Powers Rules, 1975, the Government is pleased hereby to prohibit the holding of and taking part in any procession, meeting or assembly in any public place or private open space for any purposes other than the following purposes, namely:—

- (1) Observance of religious rites.
- (2) Wedding and funeral.
- (3) Sports and games.
- (4) Cultural functions.
