No. S.R.O. 36-L/83.—In pursuance of the proclamation of the 24th March 1982, and in exercise of all powers enabling him in that behalf, the Chief Martial Law Administrator is pleased to make the following further amendment in the Bangladesh Services (Recreation Allowance) Rules, 1979, namely :—

In the aforesaid Rules, in rule 2, in clause (b) :—

- (a) for the words "one month" the words "fifteen days" shall be substituted ; and
- (b) for the words "one month's" the words "fifteen days" shall be substituted.

2. The amendment shall, in respect of Government servants in the National Board of Revenue, be deemed to have taken effect from the 5th January, 1982, and in respect of others, from the date of the publication of this Notification.

CHITTAGONG HILL TRACTS

PROCLAMATIONS

Martial Law Case No. 1 of 1983 corresponding to Khagrachari G.R. Case No. 17 of 1982, Mahalchari P.S. Case No. 2, dated 24th May, 1982.

Whereas it has been made to appear to me that the accused Mr Shanti Kusum Chakma *alias* Artish Babu *alias* Artick Babu, son of Probin Chandra Chakma of Kularampara, 248, Mobachari Mouza, P.S. Mahalchari, district Chittagong Hill Tracts, is required for the purpose of trial in the Summary Martial Law Court No. 27, Khagrachari ;

And whereas the Court has reason to believe that the said accused Mr Shanti Kusum Chakma in the case abovementioned, is absconding or concealing himself to avoid appearance or arrest for the said purpose ;

Case No. 10/81, failing which he will be tried *in absentia* and his properties, both movable and immovable, may be forfeited to the Government.

**Martial Law Case No. 5 of 1983 corresponding to Khagrachari G.R. Case No. 6 of 1981, Panchari P.S. Case No. 1, dated 8th March 1981.**

Whereas it has been made to appear to me that the accused Mr Susil Kanti Chakma, son of Sukamal Chakma of Gachban Barua Para, P.S. Khagrachari, district Chittagong Hill Tracts, *ex-Store-Keeper*, B.A.D.C. Store, Panchari, is required for the purpose of trial in the Summary Martial Law Court No. 27 Khagrachari ;

And whereas the Court has reason to believe that the said accused Sushil Kanti Chakma in the case abovementioned, is absconding or concealing himself to avoid appearance or arrest for the said purpose ;

Now, therefore, in exercise of the powers conferred by Regulation 2(11) of the Martial Law Regulation No. I of 1982, this Summary Martial Law Court No. 27, do hereby direct the aforesaid accused person to appear in this Court at Khagrachari on 17th February 1983 at 10 a.m. in Case No. 5/83 corresponding to Khagrachari G.R. Case No. 6/81, failing which he will be tried *in absentia* and his properties, both movable and immovable, may be forfeited to the Government.
