# OFFICE OF THE CHAIRMAN SPECIAL MARTIAL LAW COURT No. 1, DACCA.

Whereas it has been made to appear to that Mr Nasiruddin, son of Abdus Samad of Vill. Kalindi, P.S. Karaniganj, Dist. Dacca, is required for the purpose of trial in this Special Martial Law Court No. 1, Dacca, under M.L.R. 11 of M. L. R. 1 of 1975.

And whereas this court has reason to believe that the said Mr Nasiruddin is absconding or concealing himself to avoid appearance for arrest for the said purposes;

Now, therefore, in exercise of the powers conferred by Martial Law Regulation 11 of M.L.R. 1/75 this Special Martial Law Court No. 1, Ganabhaban, Dacca, do hereby direct-

(a) The said Nasiruddin to appear in this Court at Ganabhaban, Dacca, on 25th February 1976 in Martial Law Case No. 19 of 1975 failing which he will be tried in absentia and his properties may be forfeited to the Government. .
