(5) Mr Md. Abdul Hadi, Advocate, son of late Md. Abdul Gafoor, Rajshahi.

(6) District Controller of Food, Rajshahi.

(7) Town Rationing Officer, Rajshahi—*Member-Secretary.*

The Rajshahi Ration Shop Selection Committee (hereinafter referred to as the Committee), shall perform the following functions, namely:—

### **Functions:**

(a) **Selection of Ration Shops.**—Whenever any necessity for opening of a new ration shop or for filling up of a vacancy caused by the demise of a Ration dealer or by virtue of surrender of a ration shop by the owner will arise in any particular sub-area, the Member-Secretary shall invite applications from the intending candidates and cause the same duly enquired into by the officers concerned of the Rationing Department. After considering the applications and the enquiry reports, the Committee shall select for appointment as Ration Shop Dealers the candidates considered best suited.

(b) **Surrender and Transfer.**—All applications for surrender of a ration shop or transfer of ownership of the same shall be disposed of by the Committee.

**Procedure:**

All decisions are to be taken by the Committee in a meeting which will be convened by the Member-Secretary, whenever any such meeting becomes necessary for performance of the functions assigned to the Committee. Three members will form the quorum, of which at least one member should be non-official. In case of a difference of opinion, the opinion of the majority of the members present shall prevail. In the light of the decisions taken by the Committee, formal orders will be issued by the Town Rationing Officer, Rajshahi.

**Revision:**

The Government may modify or revise any decision of the Committee.

This order will come into force with immediate effect and shall remain in force until further orders.
