# MINISTRY OF COMMERCE AND FOREIGN TRADE (Foreign Trade Division)

#### Dacca, the 19th February 1975.

- No. S.R.O. 84L/75.—In exercise of the powers conferred by section 27 of the Finance Act, 1974 (XLIV of 1974), read with section 18 thereof, the Government is pleased to make the following rules, namely—
- 1. (1) These rules may be called the Import Licence Tax (Assessment and Collection) Rules, 1975.
  - (2) These rules shall come into force on the 3rd March, 1975.
- 2. (I) Before a letter of credit is opened against an import licence issued on or after the 3rd March 1975, the banks opening the letter of credit shall calculate the import licence tax at the rate of 20 per cent. of the value of the letter of credit and realise the amount from the importer.
- (2) No bank shall open a letter of credit unless the import licence tax so calculated has been realised from the importer.
- 3. (I) The banks shall, within seven days of the realisation of the tax from the importers deposit the amount into a Treasury, Sub-Treasury or a bank functioning as Treasury against Treasury challans.
- (2) All amounts realised as import licence tax shall be deposited under the head "XIII—Other taxes and duties—Other items—tax on import licence".
- 4. (I) While depositing the import licence tax under rule 3, the banks shall use a set of separate challan forms consisting of five copies of such forms for each letter of credit.

- (2) The Treasury or Sub-Treasury or the bank function as Treasury shall, after the deposit is made under rule 3, return three copies of the receipted challans to the bank depositing the amount.
- (3) The original copy of the receipted challan shall be harded over by the bank to the importer concern for production, if necessary, before the customs authorities at the time of clearance of the goods.
- (4) One copy of the challan shall be forwarded to the concerned licensing office along with the weekly statement required to be submitted under rule 5.
- 5. (1) The banks realising the import licence tax shall foreward on each Monday, a weekly statement showing the realisations of the tax made during the preceding week to the concerned licensing office of the Chief Controller of Imports and Exports and the Bangladesh Bank.
  - (2) The statement under sub-rule (1) shall include the following particulars:-
    - (i) Name of the importer;
    - (ii) Address of the importer;
    - (iii) Import Registration Certificate number (where applicable);
    - (iv) The date of issue of import licence;
    - (v) Number of the licence;
  - (vi) Value of the licence;
  - (vii) Item licensed;
  - (viii) Amount of the letter of credit;
  - (ix) Amount of the tax realised; and
  - (x) Number and date of the Treasury challan, if already paid into a Treasury.

- 6. In the case of imports for which no import licence is required a and, a letter of credit is opened against specific allocation of foreign exchange 12/4, in cases where import licence was issued before the first day of July, these but the letter of credit was not opened before the coming into force of rules, the import licence tax shall be realised by the banks before opening the letter of credit.
- 7. (I) In the case of imports for which letter of credit was opened before the first day of Ju'y, 1974, the imorter concerned shall pay import licence tax at the rate of 20 per cent. of the value of the licence into a Treasury, Sub-Treasury or a bank functioning as Treasury under the head mentioned in sub-rule (2) of rule 3 against challan and produce the receipted copy of the Treasury challan to the Collector of Customs before clearance of the goods;
- (2) The Confector of Customs shall forward a monthly statement of realisation of the import licence tax under this rule to the Chief Controller of Imports and Exports in the manner specified in rule 5.

Note—The statement forwarded to the licensing office shall be supported by copy of the receipted challan as per sub rule (4) of rule 4.

- 8. On the case of imports against import permits and clearance permits, the import licence tax shall be paid by the importer against Treasury challan and the importer shall produce a receipted copy of the challan to the Controller of Imports and Exports before taking delivery of the import permit or clearance permit, as the case may be.
- 9. On the coming into force of these rules, the Import Licence Tax (Assessment and Collection) Rules, 1974, shall stand repealed.

No. S.R.O. 85-L/75/S-VI/3R-5/75/19-In exercise of the powers conferred by clause (1) of Article 24 of the Bangladesh Local Government (Union Parishad and Paurashava) Order, 1973 (P. O. No. 22 of 1973), read with Article 22 thereof and Article 89 of the Basic Democracies Order, 1959 (P. O. No. 18 of 1959), the Government is pleased to make the following further amendment in the Local Councils (Constitution and Functions of Agricultural Development Committee) Rules, 1963, namely:-

#### Amendment.

In the said Rules, in rule 3, for item (A) the following shall be substituted namely:-

- "(A) UNION AGRICULTURAL DEVELOPMENT COMMITTEE.
- (i) Chairman (Ex-Officio)-Chairman of the Union Parishad.
- (ii) Vice-Chairman (Ex-officio)-Vice-Chairman of the Union Parishad.
- (iii) Members-Three members to be nominated by the Union Parishad from amongst its members so that there is one member from each Ward and not more than three members to be nominated by the Subdivisional Agriculture Officer from amongst the enlightened farmers of the union:

Provided that not more than one member shall be nominated by the Subdivisional Agriculture Officer from one ward:

Provided further that a member nominated by the Subdivisional Agriculture Officer shall have no right to vote.

(iv) Secretary-Union Agricultural Assistant:

Provided that the Secretary shall have no right to vote."

- 4. The basis of licensing to Cigarette industry on deferred payment basis as indicated against serial No. 6 of Appendix I of this office Public Notice No. 7(75)/Import, dated 21st January 1975 will stand suitably modified so that total imports of cigarettee paper and aluminium foil by the eligible units do not exceed 100% of their half-yearly entitlement for these two items.

No. 797-G.—On re urn from New Zealand after attending the Sixth Asian Judicial Conference Mr Justice Abusadat Mchammad Sayem, Chief Justice of Bangladeshh resumed his duties on the 16th February 1975, in the afternoon.

No. 799-G.—During the absence of Justice Abusadat Mohrmmad Sayem, the Chief Justice of Bangladesh from the country Mr Justice Syed Abu Basher Mahmud Husain, the next most senior Judge of the Appellate Division of the Supreme Court of Bangladesh, performed the functions of the office of the Chief Justice from the afternoon of 31th January 1975 till the return of the Chief Justice to the country in the afternoon of 16th February 1975.
