No. S.R.O. 93-L/83.—The following draft of certain further amendments to the Copyright Rules, 1967, which the Government proposes to make in exercise of the powers conferred by section 82 of the Copyright Ordinance, 1962 (XXXIV of 1962), is hereby published, as required by sub-section (1) of the said section 82, for information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration on or after the 31st March, 1983. Any objection or suggestion with respect to the said draft which may be received by the undersigned before the date specified will be duly considered by the Government:

Draft Amendments

In the aforesaid Rules,—

(1) throughout the rules, unless otherwise specified—

(a) for the word "Pakistan" the word "Bangladesh" shall be *substituted*;

(b) for the words "Central Government" the word "Government" shall be *substituted*; and

(c) for the word "Karachi" the word "Dhaka" shall be *substituted*;

(2) in rule 3, for sub-rule (1), the following shall be substituted, namely,—

“(1) The Register shall be kept in five parts as follows :—

Part I.—Literary, Dramatic and Musical works.

Part II.—Artistic works.

Part III.—Cinematographic works.

Part IV.—Records.

Part V.—Broadcasts”;

(3) in rule 20,—

(a) in sub-rule (1), for the words “three years” the words “five years” shall be substituted;

(b) for sub-rule (4) the following shall be substituted, namely :—

“(4) The Chairman and other members of the Board shall be paid such salary or honorarium or conveyance allowance as may be determined by the Government in each case”;

(4) in rule 24,—

(a) for sub-rule (2), the following shall be substituted, namely :—

“(2) The fees shall be paid to the Registrar by a bank draft from any scheduled bank of Bangladesh or by deposit into a Government treasury or sub-treasury under the Head of Account No. XLVI—Misc. Copyright fees”;

“(4) Where payment is made by deposit in a Government treasury or sub-treasury, the original copy of the challan evidencing the payment shall be sent to the Registrar by registered post or by hand”;
