**Terms of reference :**

2. The Committee will consider the following:
  - (a) Finalisation of—
    - (i) the Training Syllabus for the Ansars, VDP/TDP members;
    - (ii) the Training Syllabus for Instructors of Ansars and VDP.
  - (b) The Training Syllabus will be drawn up by the Director-General, Ansars and VDP in consultation with the Army Headquarters, the BDR and the Police Directorate and then placed before the Committee for finalization.
