O. 112-L/76/9/Excise.—In exercise of the powers conferred by the provisions contained in the third column of sub-item (1) of item 21 of the First Schedule to the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to make the following further amendment in this Ministry's Notification No. S. R. O. 214-L/75/10/75-Excise, dated the 23rd June, 1975, namely :—

In the aforesaid Notification, in the Table, against serial No. 8, in column 1, *after* entry (e) in column 3 and the entry relating thereto in column 4, the following new entry (f) shall be *added*, namely :—

PUBLIC NOTICE NO. 14(76)/IMPORT

Dacca, the 15th March 1976.

It is hereby notified for information of all concerned that the last date for receipt of applications for admission as New Comers by Registered Post, Acknowledgement Due, under paragraph 9 of the Import Policy (January—June, 1976) Order has been extended from 15th March, 1976 to 15th April, 1976. Those who have paid the requisite amount of income tax by 31st December, 1975 instead of 30th November, 1975 as notified earlier, will also be eligible to apply. Other conditions shall remain unchanged.

2. The last date for submitting licence forms to the respective Licensing Authority by the Actual Users under paragraph 10 of the Import Policy (January—June, 1976) Order has also been extended from 15th March, 1976 to 15th April, 1976.

3. The following amendments in the Import Policy (January—June, 1976) Order are also notified for information of all concerned:—

(i) At the end of the paragraph 25(a), the following sentence shall be inserted:

“Under this paragraph, an exporting industrial unit will be allowed to import spares and machinery for balancing, modernisation and replacement for its own use for an amount not exceeding Tk. 3.00 lakh (Taka Three lakh) at a time.”

(ii) In the first line of Note below paragraph 25(c) the word “perishable” shall be *deleted*.

(iii) In the fifth line of paragraph 25(f) (ii) the sentence:

“Further, the restrictions imposed in paragraph 13 of Annexure IV of this Order in respect of items listed in Annexure XI will also apply.” shall be *deleted*.
