No. S.R.O. 127-L/83/92-Excise.—In exercise of the powers conferred by the provisions of column 3 of the First Schedule to the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to make the following further amendment in this Division's notification No. S.R.O. 203-L/81/41-Excise, dated the 6th June, 1981, namely:—

In the aforesaid Notification, in TABLE 1, for item No. 01.03(2)(i) in column 1 and the entries relating thereto in columns 2 and 3, the following shall be substituted, namely:—

"01.03(2)(i) Tea packed in any kind of package, container or bag on which retail price and weight are legibly, prominently and indelibly printed and if such retail price—
