এস, আর, ও নং ১৩১-আইন/২০০৪/বিজ্বাখস-(অপা-২) — খনি ও খনিজ সম্পদ (নিয়ন্ত্রণ ও উনুয়ন) আইন, ১৯৯২ (১৯৯২ সনের ৩৯ নং আইন) এর ধারা ৪ এ প্রদন্ত ক্ষমতাবলে সরকার, The Mines and Minerals Rules, 1968 এ নিম্নরূপ অধিকতর সংশোধন করিল, যথা ঃ—

- (季) rule 2 의록-
  - (অ) clause (c) এর পর নিম্নরপ নৃতন clause (cc) সন্নিবেশিত হইবে, যথা ঃ---
    - "(cc) "District Committee" means a committee constituted by the Government by notification in the official gazette from time to time;";
  - (আ) clause (g) এর পর নিম্নরপ নৃতন clause (gg) সন্নিবেশিত হইবে, যথা ঃ---
    - "(gg) "lessee" means a person to whom a quarry lease or mining lease is granted and also includes his successor in interest;";
  - (ই) clause (m) এর পর নিমন্ত্রপ নৃতন clause (mm) সন্নিবেশিত হইবে, যথাঃ—

    "(mm) "ordinary sand and ordinary stone" means the item

    mentioned in section 2 (kha) (e) of the Act;";

- (ঈ) clause (q) এর পর নিম্নরপ নৃতন clause (qq) সন্নিবেশিত হইবে, যথা ঃ---
  - "(qq) "quarry lease money" means the quarry lease money determined each year jointly by the representatives of the Bureau, Geological Survey of Bangladesh and the Deputy Commissioner of the concerned District;";
- খে) rule 5 এর sub-rule (1) এর "A licensee or a lessee shall, within 60 (sixty) days after the granting license or lease, get the licensed or leased out area demarcated by a surveyor, recognized by the Bureau in presence of an officer specified in his behalf by the Director, and such demarcation shall be made in the following manner" শক্তাল ও কমাণ্ডলির পরিবর্তে "A licensee or a lessee shall, within 30 (thirty) days from the date of granting the license or lease, get the licensed area or leased area demarcated by a surveyor appointed by the Deputy Commissioner in presence of an officer authorized by the Director and an officer authorized by the Deputy Commissioner of the concerned District and such demarcation shall be made in the following manner" শক্তাল ও কমাণ্ডলি প্রতিস্থাপিত হইবে;

  - "7. Non-refundable application fee.—(1) Every application shall be submitted along with the original copy of the treasury challan showing the payment of non-refundable fee of—
    - (a) Taka 3,000-00 (three thousand) for exploration license for the first 100 (one hundred) hectares or any part thereof; and Taka 100-00 (one hundred) for each additional hectare or any part thereof;
    - (b) Taka 10,000-00 (ten thousand) for the first 30 (thirty) hectares or any part thereof, and Taka 200.00 (two hundred) for each additional hectare or any part thereof in the case of a quarry lease;
    - (c) Taka 2,000.00 (two thousand) where quarry lease money for ordinary sand and ordinary stone is less than Taka 15,000.00 (fifteen thousand); and Taka 10,000.00 (ten thousand) where quarry lease money for ordinary sand and ordinary stone is more than Taka 15,000.00 (fifteen thousand);
    - (d) Taka 75,000·00 (seventy five thousand) for a mining lease for the first 100 (one hundred) hectares or any part thereof; and Taka 300·00 (three hundred) for each additional hectare or any part thereof.

- (2) The application form may be obtained on payment of a fee of Taka 500.00 (five hundred) for each copy.
  - (3) The fees mentioned in sub-rule (1) shall be deposited in the Head of Accounts 1/4241/0000/2681 by a tresury chalan.";

  - "(la) The Deputy Commissioner shall also maintain separate register of applications for quarry lease for ordinary sand and ordinary stone in the form set out in Forth Schedule as is applicable to each case.";
- (৬) rule 9 এর sub-rule (7) এর পর নিম্নরপ নৃতন sub-rule (8), (9), (10), (11) এবং (12) সংযোজিত হইবে, যথা ঃ—
  - "(8) Upon receipt of an application for quarry lease for ordinary sand and ordinary stone, the Deputy Commissioner or an officer, authorized by him in his behalf, shall put his signature and official seal with date and time on the application, and on the receipt to be delivered to the applicant.
  - (9) The Deputy Commissioner shall forward the applications to the District Committee for recommendation for selection of the lessee.
  - (10) On receipt of the applications under sub-rule (9), the District Committee will examine and send the same to the Director with recommendations for granting the lease.
  - (11) On receipt of the recommendation and the application under sub-rule (10), the Director shall issue a letter to the applicant informing the approval of lease and to deposit the quarry lease money within a period of 15 (fifteen) days from the date of issuance of such letter.
  - (12) The Director shall, upon deposit of the quarry lease money by the lessee, grant quarry lease on the basis of the recommendation of the District Committee.";

  - "27A.—Annual fee.—The licensee or the lessee shall, on or before the 31st of March of each calendar year, pay a fee for that calendar year at the rate of Taka 100.00 (one hundred) per hectare or any part:

Provided that, where a license or a lease is granted after the 31st March of a calendar year, the fee for that year shall be payable within two months from the date after such granting:

Provided further that, if such fee is not paid on or before the said date or within the said two months as the case may be, a penal fee at the rate of 05% of such annual fee shall be paid for each day of default with effect from the 1st January of that year or, from the date of granting the license or the lease, as the case may be, and if the fee and the penal fee is not paid within 180 (one hundred eighty) days after the said date, the license or the lease shall be liable to be cancelled with notice.":

  - "27R.—Disposal of mineral.—(1) Subject to rule 64, the lessee shall not dispose of any mineral produced without measuring it in presence of an officer authorized by the Director.
  - (2) Nothing of sub-rule (1) shall apply to the quarry lease for ordinary sand and ordinary stone.";

    - "55A. Leased area and register.—(1) Except as otherwise decided by the Government, a quarry lease shall not be granted in respect of any area measuring more than 30 (thirty) hectares.
    - (2) On the basis of the practical situation, if necessary, an area which is more or less than 30 (thirty) hectares of an ordinary sand quarry can be granted as an individual quarry.
    - (3) The leasing authority shall maintain a register in the form set out in Thirteenth Schedule for quarry lease.";

    - **"55B. Period of quarry lease and its renewal.**—(1) A quarry lease shall be granted for a period of maximum 1 (one) year from the date of granting lease.
    - (2) Subject to payment of royalty or quarry lease money and other outstanding dues of the quarry lease, the leasing authority reserves the right to grant renewal of the lease for a period of not exceeding 1 (one) year at a time and the lessee shall have no option to claim renewal as a matter of right:

Provided that the leasing authority shall not, without prior permission of the Government, renew any such lease except ordinary sand and ordinary stone quarry.

- (3) The lessee shall apply in writing to the leasing authority for renewal at least 60 (sixty) days prior to the expiry of the lease thereof.
- (4) In the case of quarry lease for ordinary sand and ordinary stone, the lessee shall apply to the concerned Deputy Commissioner for renewal at least 60 (sixty) days prior to the expiry of the lease thereof.
- (5) Upon receipt of an application under sub-rule (4), the Deputy Commissioner or an officer, authorized by him in his behalf, shall put his signature and offical seal with date and time on the application, and on the receipt to be delivered to the applicant.
- (6) The Deputy Commissioner shall forward the applications to the District Committee for recommendation of the renewal of the lease.
- (7) On receipt of the applications under sub-rule (6), the District Committee shall examine and send the same to the director with recommendations for renewing the lease.
- (8) On receipt of the recommendation and the application under sub-rule (7), the Director shall direct the applicant to deposit the quarry lease money within a period of 15 (fifteen) days from the date of such direction.
- (9) The Director shall, upon deposit of the quarry lease money by the lessee, renew the quarry lease for further period.
- (10) If the lessee fails to apply for renewal within the period mentioned in sub-rule (3) the lease shall stand terminated.";

  - "55C. Rights of the lessee.—(1) The lessee shall have the right to establish, within the boundaries of his quarry area, machineries and equipment for excavating, crushing, sizing, stocking the quarried minerals or rocks and make transportation facilities.
  - (2) The Director shall give permission to the lessee to establish the machineries and equipments in ordinary sand and ordinary stone quarry on recommendation of the concerned Deputy Commissioner.";

- (a) a statement of the depth reached in each drill hole or pit; and
- (b) a statement of geological or other geoscientific work or data that has been carried out.":
