NOTIFICATION

Dhaka, May 25, 1983

No. 4/10/83-Rules/110.—Government have been pleased to make, with immediate effect, the following further amendments in the Allocation of Business among the different Ministries and Divisions (Schedule I of the Rules of Business, 1975) revised up to July, 1982:—

In the aforesaid Schedule I,—

- (a) under the heading "2. CMLA's Secretariat", under sub-heading "D. Science and Technology Division" the entries from 1 to 23 shall be *omitted* and the same shall be *substituted* as under:—
- (1) Formulation and review of national policies on Science and Technology in pursuance of National objectives and plans;
 - (2) Implementation of recommendations of the National Committee on Science and Technology (NCST);
 - (3) National bodies on science and technology;
 - (4) Development of oceanographic science;
 - (5) Peaceful uses of outer space and atmospheric research;
 - (6) Development of electronics and its co-ordination amongst various users;
 - (7) Co-ordination of areas of science and technology in which other Ministries have interests and capabilities;

- (8) Undertaking and financially sponsoring of scientific and technological surveys, research, design and development where necessary;
 - (9) Grants to national research institutions, scientific associations and scientific bodies;
 - (10) Matters concerning domestic/appropriate technology particularly the ventures including the commercialisation of technology;
 - (11) All other measures needed for the promotion of science and technology and their application to the development and security of the nation;
 - (12) Matters concerning the Museum of Science and Technology;
 - (13) Matters relating to scientific and technological documentation including National Science Library;
 - (14) Promotion of new areas of science and technology;
 - (15) Observation of National Science Week in collaboration with the research bodies/educational institution;
 - (16) Liaison with international organisations and matters relating to treaties and agreements with other countries and world bodies relating to subjects allotted to this Division;
 - (17) All laws on subjects allotted to this Division;
 - (18) Inquiries and statistics on any of the subjects allotted to this Division;
 - (19) Fees in respect of any of the subjects allotted to this Division except fees taken in courts.
- (b) under the heading "13. Ministry of Industries and Commerce", under sub-heading "B. Industries Division" after "entry 13" the new entries shall be *inserted* as under:—
- "13A. Standardization of weights and measures.
 - 13B. Testing and quality control of industrial and commercial products.
 - 13C. Matters relating to Bangladesh Standard and Testing Institution."
- (c) under the heading "19. Ministry of Works", after "entry 4" the new entries shall be *inserted* as under:—
- "4A. Research on building materials.
 - 4B. Matters relating to Building Research Institute."
- (d) under the heading "17. Ministry of Local Government, Rural Development and Co-operatives", under sub-heading "A. Local Government Division", after "entry 12", the new entries shall be *inserted* as under:—
- "12A. Environment and ecology.
 - 12B. Matters relating to environment pollution control."

- (e) under the heading "7. Ministry of Energy and Mineral Resources", under sub-heading "B. Petroleum and Mineral Resources Division", after "entry 6" the new entry shall be inserted as under:—

"6A. Development of Geological and Geophysical sciences."

- (f) under the heading "11. Ministry of Health and Population Control" after "entry 26." the new entry shall be inserted as under:—

"26A. Matters relating to Bangladesh Medical Research Institute."

Dhaka, the 31st May 1983

No. S.R.O. 173-L/83.—In exercise of the powers conferred by sub-section (6) of section 5 of the Income Tax Act, 1922 (XI of 1922), the National Board of Revenue is pleased to make the following further amendments in its Notification No. S.R.O. 125-L/76, dated the 3rd April, 1976, namely:—

In the aforesaid Notification, in the Schedule,—

- (a) against Sl. No. 2, in column 1, in column 3, entry (f) and the entries relating thereto shall be *omitted*;
- (b) after Sl. No. 3, in column 1 and the entries relating thereto, the following shall be *added*, namely:—

- "4. The Commissioner of Taxes, Dhaka (West) Zone, Dhaka. (a) Volkart (Bangladesh) Limited, Sadarghat, Chittagong, C/o. Orr Dignam & Co., C.D.A. Building (3rd floor), Chittagong."
