No. S.R.O.179.L/83/MVRT/1A-3/82.—The following draft of certains further amendments to the Motor Vehicles Rules, 1940, which it is proposed to make, in exercise of the powers conferred by section 70 of the Motor Vehicles Act, 1939 (IV of 1939), is hereby published as required by sub-section (1) of section 133 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration on or after 7th July, 1983. Any objection or suggestion received from any person in respect of the said draft on or before the date so specified will be taken into consideration by the Government:

Draft Amendments.

In the aforesaid Rules, in rule 114-

- (a) in sub-rule (a), for the words "a horn" the words "an electric horn or a bulb horn" shall be substituted;
 - (b) in sub-rule (b), after the words "shall be fitted with"; the words "any air pressure horn on pneumatic horn or vacuum horn or" shall be inserted;
 - (c) in sub-rule (d), after the words "fitted with", the words "an electric horn or" shall be inserted;

- (d) after sub-rule (d), the following new sub-rule shall be inserted, namely:—
 - "(e) Any police officer of or above the rank of Sub-Inspector of Police or any Inspector of Motor Vehicles may get removed any horns other than an electric horn or a bulb horn fitted to any motor vehicle and may dispose of the horns so removed in the manner he deems fit."

MINISTRY OF WORKS NOTIFICATION

No. S.R.O.180-L/83.—In exercise of the powers conferred by Article 25 of the Bangladesh Abandoned Property (Control, Management and Disposal) Order, 1972 (P.O. No. 16 of 1972), the Government is pleased to make the following further amendment in the Bangladesh Abandoned Property (Buildings in the Urban Areas) Rules, 1972, namely:—

In the aforesaid Rules, in rule 10,-

- (1) in sub-rule (1),-
 - (a) in clause (b), the word "and" at the end shall be omitted;
 - (b) in clause (c), for the full-stop at the end a comma shall be substituted and thereafter the following new clause shall be added, namely:—
 - "(d) disposal by sealed tender.";
- (2) after sub-rule (4), the following new sub-rule shall be inserted, namely:—
 - "(4A) For disposal of a building by sealed tender, the terms and conditions of the bidding and the manner of realisation of the price of the building shall be determined by the Government from time to time.";
- (3) in sub-rule (5), after the word "auction", the words "or by sealed tender" shall be inserted.

NOTIFICATION

No. SIX/5M-20/83/388.—In the Ministry of Education Notification No. SIX/5M-20/83/259, dated the 10th April 1983, the following amendments shall be made, namely,—

- (a) there shall be a Vice-Chairman of the Consultative Committee on Education;
- (b) the number of representatives of Bangladesh Government College Teachers' Association shall be four instead of two;
- (c) the number of representatives of Bangladesh College Teachers' Association shall be four instead of two;
- (d) there shall be one representative from Bangladesh Federation of Teachers' Associations on the Committee; and
- (e) the number of representatives of Teachers' Association (non-Govt. Secondary Schools) shall be four instead of two.
