### NOTIFICATION

No. S.R.O. 190-L/83-S-1/1R-76/83/295.—In exercise of powers conferred by section 140 of the Co-operative Societies Act, 1940 (Bengal Act XXI of 1940), the Government is pleased to make the following amendment in the Co-operative Societies Rules, 1942, the same having been previously published as required by sub-section (i) of that section in the Bangladesh Gazette, dated May 30, 1983:

#### Amendment

In the aforesaid Rules, in rule 35, in sub-rule (1), for clause (d), the following shall be substituted, namely:—

"(d) or the society which he represents has failed to pay to the society at least 75% of the loans, advances or any other kind of dues or instalments thereof repayable by him or, as the case may be, by the society which he represents,".
