In partial modification of the provisions of the Import Policy (July-December, 1975) Order, it is hereby notified for the information of all concerned that henceforth, import licence under cash will be issued with the condition that Letters of Credit be established within three months from the date of its issue. In case of cash licences issued prior to the issue of this Public Notice, Letters of Credit must be opened by 31st October 1975 or within three months from the date of issue of the licence, whichever is later.

In all cases where basis of licensing under cash has already been announced, the last date for submission of licence from both for commercial and industrial importers shall be 31st October 1975. In case of repeat licences, however, licence forms may be submitted by 20th December 1975.

PUBLIC NOTICE NO. 81(75)/IMPORT

Dacca, the 20th September 1975.

It is hereby notified for the information of all concerned that actual user licences will issue for Marine Diesel Engine and spares up to 10 per cent of the value of the engine, for use in cargo vessels and new passenger launch.

- Licences will issue under OECF Loan BD-C2 of Japan and licence forms, which will be treated as application for licence, should be submitted through a scheduled bank and shall be accompanied by the following documents:
 - (a) A statement from the applicant that he will import himself for use in his cargo vessel/passenger launch and that he has not applied for any other licence for engine in his own name or in benami. The signature of the applicant on the statement should be authenticated by the Manager of the Bank through whom the licence form is presented. The statement shall also contain the full business address of the applicant.
 - (b) Suppliers' proforma invoice in respect of the engines eligible under OECF Loan No. BD-C2.
 - (c) A certificate from the Scheduled Bank, through whom the licence form is presented, to the effect that at least 20% of the price has been deposited with the bank for opening letters of credit for the import of the engines applied for, and that the applicant will be in a financial position to retire the documents when the import consignment is received.
- Importers will be required to have the plan and design of their vessels approved by the IWTA in due course as required by the said Authority.
- 3. Because of the short validity of the OECF Loan No. BD-C2, letters of credit must be opened within 15 days from the date of issue of Import licence failing which the import licence will be treated as invalid.
- 4. Licence forms not accompanied by the prescribed documents will be rejected. The licence forms must be submitted to the respective licensing counter at Dacca, Chittagong, Rajshahi, Khulna, Sylhet and Rangpur on or before 17th October 1975.
- 5. Licences will issue under intimation to the Registrar of Inland Shipping and IWTA.

PUBLIC NOTICE No. 83(75) IMPORT

It is hereby notified for information of those Industrial units who were issued licences for import of dyes and chemicals under French Grant to Bangladesh for F. Y. 1973-74 but could not open letters of credit due to exhaustion of fund that they can now process their letters of credit by 30th October 1975 under French Loan, dated 22nd June 1974 through Sonali Bank who are the designated Bank for French Loan. All requests for opening letters of Credit under French Loan in such cases must be accompanied by a certificate from the Designated Bank for French Grant (i.e. Agrani Bank) in duplicate to the effect that letters of credit could not be opened due to exhaustion of fund.
