নং স, বি/এ২-১৪০/৭৫-০৪৫—গণপ্রজাতদন্তী বাংলাদেশ সরকার অতীব দুঃথের সহিত জানাইতেছেন যে বিগত ২৬শে আগণ্ট, ১৯৭৫ তারিখের দিবাগত রাত্র প্রায় ১২-৪০ মিনিটের সময় নোয়াখালীর জেলা ও দায়রা জজ মিঃ জ্যোতিময় চরুবতী চিকিংসাথে ঢাকা আসার পথে হদরোগে আরুন্ত হইয়া মৃত্যু বরণ করিয়াছেন। মিঃ জ্যোতিময় চরুবতার এই আকস্মিক ও অকাল মৃত্যুতে সরকার গভীর শোক প্রকাশ করিতেছেন।

মিঃ জ্যোতির্মার চক্রবতী ১৯১৯ সালের প্রেলা ফেব্রুরারী সিলেট জেলায় জন্ম-গ্রহণ করেন। তদানীন্তন পূর্ব পাকিস্তান সিভিল্ন সাভিসে (জ্বডিসিয়াল) প্রীক্ষায় উত্তীপ হইয়া তিনি ১৯৫০ সালের প্রেলা আগত ১ম সরকারী চাকুরীতে যোগদান করেন।

তাঁহার কর্মায় জীবনে তিনি সরকারের নানা গ্রেক্সেণ্র্ণ পদে অধিষ্ঠিত ছিলেন। তাঁহার কর্মাদক্ষতা ও সন্তোযজনক চাকুরীর জন্য সরকার তাঁহাকে ১২ই এপ্রিল, ১৯৭৩ সালে জেলা ও দায়রা জজ পদে পদোর্মাত দিয়া নোয়াখালী জেলায় জেলা ও দায়রা জজ পৃদে নিয়োগ করেন। এই পদে বহাল অবস্হায় তাঁহার কর্মায়য় জীবনের অবসান হয়। তিনি একজন দক্ষ ও কর্মপরায়ণ অফিসার ছিলেন।

বাংলাদেশ সরকার মিঃ জ্যোতিম্য চক্রবতীর মৃত্যুতে তাঁহার বিধবা পদ্দী ও শোকসন্তহত পরিবারের প্রতি আন্তরিক সহান্ত্তিও গভীর সমবেদনা প্রকাশ করিতেছেন এবং তাঁহার বিদেহী আত্মার শান্তি কামনা করিতেছেন।

Income Tax.

NOTIFICATION

Dacca, the 25th September 1975.

No. S.R.O. 338-L/75.—The following draft of certain further amendments to the Income-tax Rules, which the National Board of Revenue proposes to make in exercise of the powers conferred by section 59 of the Income-tax Act, 1922 (XI of 1922), is published as required by sub-section (4) of the said section, for the information of all persons likely to be affected thereby, and notice is hereby given that the said draft will be taken into consideration on or after the 27th of October, 1975. Any objection or suggestion which may be received from any person in respect of the said draft before the date specified will be considered by the Board;

Draft Amendments.

"In the aforesaid Rules, in Rule 39, in sub-rule (1), in the Schedule,-

- (a) For serial No. 1 the following shall be substituted, namely:-
- "1. Where house rent allowance is receivable by the assessee in cash-
 - (i) Where the allowance does not exceed Nil.

 Tk. 500 per month or 15 per cent. of
 the basic salary of the assessee which
 ever of these two sums is the less.
 - (ii) In other cases

- The amount, if any, by which such allowance exceeds Tk. 500 per month or 15 per cent of the basic salary of the assessee whichever of these two sums is the higher."
- (b) After serial No. 7, the following new serial 7A with entries thereto shall be inserted, namely:—
 - "7A. Entertainment allowance-
 - (i) Where the allowance does not Nil. exceed Tk. 3,000 per annum.
 - (ii) In other cases

The amount, if any, by which such allowance exceeds
Tk. 3,000 per annum."

The amendments suggested above shall have effect in respect of assessments for any year beginning on the 1st day of July 1976 and thereafter."

Customs.

NOTIFICATION

Dacca, the 24th September 1975.

No. S.R.O. 339-L/75/259/Cus/75.—In exercise of the powers conferred by clause (c) of section 21 of the Customs Act, 1969 (IV of 1969), the National Board of Revenue is pleased to authorise repayment to the extent specified in column (3) of the table below of Customs duties paid on the importation of the raw materials specified in column (1) of the said table and used in the production or manufacutre of the goods specified in column (2) thereof, subject to the following conditions, namely:—

- (i) The goods have been manufactured according to the formula duly furnished to the National Board of Revenue showing the quantity of various imported raw materials specified in column (1) of the said table and used in the production or manufacture of the goods specified in column (2) thereof.
- (ii) The manufacturer maintains proper record of the goods manufactured in accordance with the formula referred to in sub-paragraph (i) and produces, on demand, such records and other evidence as may be required by the National Board of Revenue to satisfy itself that the imported raw materials have been used in accordance with the formula.
- (iii) The manufactured goods are exported out of Bangladesh and an application for repayment of Customs duties is presented to the proper officer of Customs within 60 days of such exportation or of the publication of this notification, whichever is the later.
- (iv) The exporter makes a declaration on the reverse of the original shipping bill or other export documents to the effect that he would claim repayment of the customs duties paid on the imported raw materials used in the production of the goods being exported.
- (v) The repayment at the rate specified shall be allowed provided that the goods exported are manufactured with the same constituents on which the rate of repayment is notified and the manufacturer-cumexporter shall immediately intimate to the National Board of Revenue and the Directorate of Inspection and Training (Customs and Excise), Dacca:—
 - (a) any change in the process of the imported raw materials;
 - (b) any changes in the composition of the manufactured goods to be exported; and
 - (c) use of any indigenous raw materials in place of the imported raw materials.

 The repayment authorised by this notification shall be admissible in respect of the goods exported from 13th March 1975 to 29th May 1975.

PUBLIC NOTICE No. 85 (75)/IMPORT

Dacca, the 24th September 1975.

The following amendments in the Import Policy (July-December, 1975) Order, as published in *Bangladesh Gazette*, *Extraordinary*, dated July 2, 1975, are notified for the information of all concerned:—

- An Annexure II under Engineering Group of Industry against serial No. 52, the following shall be inserted in column 3 in place of the existing entries:
 - "1. Parts and Components such as Stator, Rotor, Terminal Box, Ball Bearing, Capacitor, Stamping/Electrical Steel Silicon Sheet, Shaft, Nuts, Bolts, Washer and Porcelain parts.

- Enamelled copper wire, Brass sheet and rods (excluding banned items).
- Insulating materials such as Pressphan, Leatheiod Paper, Varnish, Insulating Tape and Steerings.
- 4. Aluminium Ingots and Pig Iron."
- In list III, the description of the item against serial No. 40 shall read "Spices including Zeera and Tejpatta but excluding Chillies, Gingers and Coriander Seeds" in place of the existing description.

PUBLIC NOTICE No. 86(75)/IMPORT

Dacca, the 26th September 1975.

In partial modification of the provisions of the Import Policy (July-December, 1975) Order, it is hereby notified for the information of the eligible commercial importers of finished Drugs and Medicines (Allopathic) that repeat licence for Drugs and Medicines (Allopathic) at Tk. 20,000 each will be issued on production of the copy of the Letter of Credit instead of Bill of Lading, as proof of utilisation of the initial licence.

- 2. It is further notified that in case of importation of Drugs and Medicines (Allopathic) by air, the C & F value of a particular item, as fixed by the Ministry of Health, may be exceeded provided increased freight will not entitle the importers to raise the maximum retail price, fixed by the Ministry of Health.
- 3. The importers are also informed that arrangements have been made with the Expert Committee of the Ministry of Health for issuing approval to the Proforma Invoice for import of Drugs and Medicines (Allopathic) within 10 (ten) days from the date of this Public Notice,
