## Dhaka, the 21st September, 1983

No. S.R.O. 355-L/83/ED(R-II)R-70/80.—In pursuance of the Proclamation of the 24th March, 1982, and in exercise of all powers enabling him in that behalf, the Chief Martial Law Administrator is pleased to make the following further amendment in the Bangladesh Civil Service Recruitment Rules, 1981, namely :-

In the aforesaid Rules, in rule 10,-

- (a) in sub-rule (1),-
  - (i) for the words "upgraded thanas" the word "Upazilas" shall be substituted; and
  - (ii) for the words "one hundred and sixty seven" the words "four hundred and nineteen" shall be substituted; and
- (b) in sub rule (2), for the figure "35" the figure "37" shall be substituted.

In the aforesaid Rules, rule 49C shall be omitted and shall be deemed to have been so omitted with effect on and from the 20th February, 1983.
