No. S.R.O.367-L/83.—In exercise of the powers conferred by clause (2) of Article 26 of the Bangladesh Industrial Enterprises (Nationalisation) Order of 1972 (President's Order No. 27 of 1972), the Government is pleased to transfer the lease hold interest in respect of the property together with building as given in the schedule below which was placed with all its assets and liabilities under the then Bangladesh Fertilizer, Chemical and Pharmaceutical Corporation vide this Division Notification No. NID/S-II/CFP-5/73-1470, dated the 29th May, 1973, to Bangladesh Chemical Industries Corporation for their exclusive use and control.

Government, however, reserves the right to cancel the aforesaid transfer as and when deemed necessary.
