(Customs and Sales Tax)

ORDER

Dhaka, the 7th October, 1986

No. S.R.O. 386-L/86/1034/Cus.—In exercise of the powers conferred by section 21(b) of the Customs Act, 1969 (IV of 1969), and section 4(2) of the Sales Tax Ordinance, 1982 (XVIII of 1982), the National Board of Revenue is pleased to authorise the delivery of the goods specified in the table below, imported by the Bangladesh Agricultural Development Corporation, without payment, subject to the following conditions, so much of the customs-duties chargeable thereon as is in excess of 15 per cent ad valorem and to grant exemption from the payment of the whole of the sales-tax payable in respect of such goods, namely:—

- (1) that it is established to the satisfaction of an officer of Customs not below the rank of an Assistant Collector that the goods are imported for use in the Deep Tube-well project of the said Corporation and shall not be used for any other purpose; and
- (2) that the goods shall not be transferred to any other person or organisation within a period of five years from the date of clearance thereof by Customs authority.
