No. S.R.O. 418-L/86/155-Excise—In exercise of the powers conferred by section 12A(1) of the Excise and Salt Act, 1944 (I of 1944), the Government is pleased to make the following amendment in this Division's Notification No. S.R.O. 233-L/86/142-Excise, dated the 27th June 1986, namely:—

In the aforesaid notification, in TABLE I, in item No. 02.04(2) (ii) (a) (i) in column 1, in sub-item (a) (xvii) in column 2 and the entries relating thereto in column 3 the following shall be substituted, namely:—

- "(xvii) exceeds taka eight but does not exceed taka eight and poisha fifty.
  - (a) exceeds taka eight and poisha fifty but does not exceed taka nine.
- Taka five hundred forty-two per thousand cigarettes.
- Taka five hundred fifty-five per thousand cigarettes."
