## Dhaka, the 12th November, 1986

No. S. R. O. 437-L/86/1040/Cus.—In exercise of the powers conferred by section 219 of the Customs Act, 1969 (IV of 1969), read with item 17 of the Third Schedule thereof, the National Board of Revenue is pleased to make the following further amendment in the Passengers (Non-tourists) Baggage (Import) Rules, 1986, namely:—

In the aforesaid Rules, in rule 3,-

- (a) in sub-rule (1), in item (xi), after the figure and word "200 cigarettes", the brackets and words "(for foreign nationals only)" shall be inserted;
- (b) in sub-rule (2), for the commas, words and figure, ", including souvenirs, other than those specified in rule 4" the words, comma and figure "including souvenirs, other than new cotton sarees and articles specified in rule 4" shall be substituted.
- The amendments shall take effect on and from the 1st December, 1986.

O. 438-L/86/1041/Cus.—In exercise of the powers conferred by section 219 of the Customs Act, 1969 (IV of 1969), read with item 17 of the Third Schedule thereof, the National Board of Revenue is pleased to make the following further amendment in the Passengers (Non-tourists) Baggage (Import) Rules, 1986, namely:—

In the aforesaid Rules, in rule 4,-

- (a) in sub-rule (2), in the LIST,-
  - (i) for item 24 the following shall be substituted, namely:—
    "24. Video cassette player 100% on a value of Tk. 4,000.00 per set";
  - (ii) against item 25 in the first column, for the entries in the third column the following shall be substituted, namely:—
     "Tk. 50.00 and Tk. 200.00, respectively, on each blank and recorded cassette";
- (b) for sub-rule (3) the following shall be substituted, namely :-
  - (3) Notwithstanding anything contained in column (3) of the TABLE under sub-rule (1), a passenger returning after a continuous stay abroad of over 3 months may import, once in a year, a video cassette recorder or a video cassette player on payment of customs duty at the rate of 100% on a value of Tk. 10,000.00 and Tk. 4,000.00, respectively, per set, and when returning after a continuous stay abroad of over 6 months, may, in addition, import a Personal Computer (P.C.), the aggregate c and f value of component parts of which does not exceed Tk. 60,000.00, on payment of duty at 20% ad val., provided that he has the use of a computer in his profession".

In the aforesaid Rules, in rule 5, in sub-rule (1), in the LIST,-

(a) against item 24 in the first column, in the third column, for the figure and word "5,000.00 taka" the figure and word "4,000.00 taka" shall be substituted;

(b) against item 25 in the first column, for the entries in the third column the following shall be substituted, namely:—

"Tk. 50.00 and Tk. 200.00, respectively, on each blank and recorded cassette.".
