**No. S. R. O. 452-L/76/29-Excise.**—In exercise of the powers conferred by section 3A of the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to make the following amendment in this Ministry's notification No. S.R.O. 295-L/76/18-Excise, dated the 25th August, 1976, namely:—

In the aforesaid notification for the words "fifty poisha" the words "Taka one and fifty poisha" shall be substituted.

In the aforesaid notification, in the Table, in Sl. No. 6, in column 4,—

"(a) against item A(i) in column 3, for the figure "45" the figure "37.50" shall be substituted;

- (b) against item A(ii) in column 3, for the figures and word "45 plus 57.5%" the figures and word "38.50 plus 75%" shall be substituted; and
- (c) against item A(iii) in column 3, for the figures and word "58 plus 65%" the figures and word "54.50 plus 85%" shall be substituted."
