No. S.R.O. 465-L/86/1046/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following further amendments in this Division's Notification No. S.R.O. 218-L/86/993/Cus., dated the 27th June, 1986, namely :—

In the aforesaid Notification, in the Table,—

- (i) against Tariff Heading No. 87·02 in column (1), for item No. (iv) and the entries relating thereto in columns (2) and (3) the following shall be substituted, namely :—

“(iv) A. Buses :

(a) Bus, CBU/SKD	20% ad val.
(b) Mini-bus, CBU/SKD (Mini-bus having a seating capacity of 15 to 32 passengers excluding driver).	10% ad val.
(c) CKD Bus/CKD mini-bus	Nil.
(d) Others	50% ad val.

- (a) CBU 50% *ad val.*
 (b) CKD 20% *ad val.*; and
 (ii) against Tariff Heading No. 87·09 in column (1), for item No. (i) and the entries thereto in columns (2) and (3) the following shall be *substituted*, namely :—
 “(i) Three wheeler (auto-rickshaw)
 (a) CBU 10% *ad val.*
 (b) CKD and engine with chassis .. Nil.”
