15. The tenderers are required to quote their CCI & E's registration number in the offer and attested photocopy of the same to be submitted with offer.
16. The offered machines must be shipped from any sea port of the same country of manufacturer/origin if there is no seaport in manufacturer's country then neighbour country's seaport will be allowed. Confirmation in this regard to be submitted in the proforma invoice.
17. The successful tenderers shall be furnished 10% performance guarantee of the total value of the contract from the manufacturer within 28(Twenty Eight) days/specified time from the date of issue of notification of award (NOA) in the form of Bank Guarantee/Pay Order in USD/BD TK. from any scheduled bank/International Bank in Bangladesh in favor of Deputy Director, Bangladesh Security Printing Press, Tejgaon, Dhaka-1208.
