#### RESOLUTION

Dacca, the 29th December, 1975.

No. ADMN/B-35/75-369.—With a view to streamlining the Railway administration the Government has been pleased to decide that—

- (i) The Bangladesh Railway shall be run on the Divisional system and the existing four Divisions will continue.
- (ii) The General Manager of the Bangladesh Railway will be assisted by such number of Deputy General Managers as may be appointed from time to time. The Deputy General Managers will be staff officers to the General Manager. They will have the full powers of the General Manager in their respective sphere of duties. In exercising these powers they will be subject to such general and specific orders as may be issued from time to time by the Government and/or the General Manager.

- (iii) The Transportation Department of the Bangladesh Railway shall be renamed as the Operating Department and it will take over in addition to its present duties, the responsibility of the management of the Locomotive crews, locosheds (running side) and the marine crafts. Management of the Workshops, maintenance and repair of the rolling stocks including those on line will continue to be the responsibility of the Chief Mechanical Engineer.
- (iv) The officers of the Transportation (Traffic) and Commercial Department and also of the Mechanical Engineering Department would be eligible for appointment as Chief Operating Superintendent on the basis of merit, suitability and availability.
- (v) All first appointments to Class 1 posts and service shall be made by the Government. The General Manager may, however, make ad hoc appointments to Junior Class I posts for a period of six months only if on reference to the Public Service (First) Commission, they are unable to recommend suitable persons for appointment to the posts within a period of ten days of the reference.
- (vi) The General Manager may make promotions from Junior Class I to Senior Class I posts in the same cadre or line of promotion.
- (vii) All transfer and posting in the Junior and Senior Class I posts shall be made by the General Manager.
- (viii) All appointments and promotions to posts in the Junior Administrative Grade and above shall be made by the Government. The General Manager may, however, transfer officers in the Junior Administrative Grade except those in charge of Department and/or Division.
- (ix) Subject to the observance of general rules regulating the strength of the service, the method of recruitment (including consultation with the Public Service Commission, wherever required) and the conditions of service, the General Manager will be the appointing authority in respect of all Class II services/posts under his jurisdiction and exercise full powers in respect of their posting, transfer and discipline.
- (x) The General Manager will exercise all the powers delegated to the Heads of Department under various rules and orders issued from time to time.
- 2. These decisions will be effective from the 1st of January, 1976.
- 3. Ordered that this Resolution be published in the official Gazette.
