| | (c) Footwear made wholly or partly of cellophane, plastic or resin materials, or of rubber and synthetic or artificial rubber, or of leather or synthetic leather, the value of which does not exceed taka seventy-five per pair. | Nil |
| | (d) Parts of footwear manufactured either wholly from plastic or rubber materials or with admixture of cotton fabrics which are so made as they cannot be used otherwise than as parts of footwear, subject to the condition that the rules made under the Act are followed. | Nil |
| | (e) Clearly identifiable parts of footwear made wholly or partly from P.V.C. or rubber. | Nil." |
