"(iia) "Collector (Appeal)" means the Collector of Customs and Excise (Appeal), Chittagong and the Collector of Customs and Excise (Appeal), Dacca authorised respectively to exercise throughout the Commissioner's Division of Chittagong and the rest of Bangladesh all the powers of a Collector for the purpose of sub-rule(2) of rule 213;".

No. S.R.O. 57-L/81/623/Cus.—In exercise of the powers conferred by section 193 of the Customs Act, 1969 (IV of 1969) and in supersession of this Ministry's Notification No. S.R.O. 78/450/D/Cus., dated the 3rd October, 1978, the Government is pleased to direct that any person aggrieved by any decision or order passed in the Commissioner's Division of Chittagong and in any other place of Bangladesh except the aforesaid Commissioner's Division by an Additional Collector of Customs, Joint Collector of Customs, Deputy Collector of Customs or an Assistant Collector of Customs under section 179 of the aforesaid Act may Appeal to the Collector of Customs and Excise (Appeal), Chittagong and the Collector of Customs and Excise (Appeal), Dacca, respectively, under the aforesaid section, provided that an appeal pending before the Collector of Customs and Excise (Appeal), Dacca immediately before the publication of this Notification shall be continued and disposed of by him.

No. S.R.O. 58-L/81/Rash(Perso)Proti-16/E-80-510.—In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, and in supersession of all rules made in this behalf, the President, after consultation with the Bangladesh Public Service Commission as required by clause (2) of article 140 of that Constitution, is pleased to make the following rules, namely:—

THE GAZETTED OFFICERS (PRESIDENT'S DIVISION—PERSONAL) RECRUITMENT RULES, 1981.

- 1. Short title.—These rules may be called The Gazetted Officers (President's Division—Personal) Recruitment Rules, 1981.
- 2. Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
 - (a) "appointing authority" means the Government and includes any officer authorised by the Government to make appointment to a specified post;

- (b) "Commission" means the Bangladesh Public Service Commission;
- (c) "Division" means the President's Division (Personal);
- (d) "probationer" means a person appointed on probation to a specified post;
- (e) "recognised university" means a university established by or under any law for the time being in force and includes any other university declared by the Government, after consultation with the Commission, to be a recognised university for the purposes of these rules;
- (f) "requisite qualification" means the qualification laid down in the Schedule in relation to a specified post;
- (g) "Schedule" means the Schedule annexed to these rules; and
- (h) "specified post" means a post specified in the Schedule.
- 3. Procedure for recruitment.—(1) Subject to the provisions of the Schedule and instructions relating to reservation for the purpose of clause (3) of article 29 of the Constitution, appointment to a specified post shall be made—
 - (a) by promotion; or
 - (b) by direct recruitment; or
 - (c) by transfer on deputation.
- (2) No person shall be appointed to a specified post unless he has the requisite qualification and, in the case of direct recruitment, he is also within the age limit laid down in the Schedule for that post.
- 4. Appointment by promotion.—Appointment by promotion to a specified post shall be made on the recommendation of such Departmental Selection Committee as the Government may constitute in this behalf:

Provided that, appointment by promotion from a post of lower class to that of higher class shall be made on the recommendation of the Commission,

- Appointment by direct recruitment.—(1) Save as otherwise provided by any law for the time being in force, no person shall be appointed to a specified post by direct recruitment except in consultation with the Commission.
- (2) No person shall be eligible for appointment to a specified post by direct recruitment, if he—
 - (a) is not a citizen of Bangladesh; or
 - (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.
- (3) No appointment to a specified post by direct recruitment shall be made until—
 - (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Director of Health Services to be medically fit for such appointment and that he does not suffer from any such

- organic defect as is likely to interfere with the discharge of the duties of the specified post; and
- (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unit for appointment in the service of the Republic.
- Probation.—(1) Persons selected for appointment to a specified post, otherwise than by transfer on deputation, against a substantive vacancy shall be appointed on probation,—
 - (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
 - (b) in the case of promotion, for a period of one year from the date of such appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

- (2) Where, during the period of probation of a probationer, the appointing authority is of opinion that the conduct and work of the probationer is unsatisfactory or that he is not likely to become efficient, it may, before the expiry of that period,—
 - (a) in the case of direct recruitment, terminate his service; and
 - (b) in the case of promotion, revert him to the post from which he was promoted.
- (3) 'After the completion of the period of probation including the extended period, if any, the appointing authority,—
 - (a) if it is satisfied that the conduct and work of the probationer during the period of his probation has been satisfactory, shall subject to the provisions of sub-rule (4), confirm him; and
 - (b) if it is of opinion that the conduct and work of the probationer during that period was not satisfactory, may,—
 - (i) in the case of direct recruitment, terminate his service; and
 - (ii) in the case of promotion, revert him to the post from which he was promoted.
- (4) A probationer shall not be confirmed in a specified post until he has passed such examination and undergone such training as the Government may, from time to time, prescribe by order.
 - 7. Savings, etc.—Notwithstanding anything contained in these rules, the President may appoint any person of his choice to any specified post provided he has the requisite qualification and such person shall hold office during the pleasure of the President.
