**PROCLAMATION**

Whereas the undermentioned person is required for the trial before the Assistant Sessions Judge and Special Tribunal, Feni, Noakhali, in Special Power Act Case No. 40/81 under section 25(B), Special Powers Act, 1974;

And whereas this court has reason to believe that the said accused person is absconding only to avoid appearance or arrest for the said purpose;
