In the aforesaid Notification, in the Table of fees, under the heading "I. Ordinary Fees," in paragraph A, in sub-paragraph (1), in the proviso, for the words "three years" the words "six years" shall be substituted and shall be deemed always to have been so substituted.

NOTIFICATION

Dacca, the 8th February 1982

No. S.R.O. 68-L/82.—In exercise of the powers conferred by section 11 of the Bangladesh Travel Agencies (Registration and Control) Ordinance, 1977 (XLVIII of 1977), the Government is pleased to make the following amendments in the Bangladesh Travel Agencies (Registration and Control) Rules, 1977, namely:—

In the aforesaid Rules,-

- (1) in rule 2, for clauses (a) and (b) the following shall be substituted, namely:—
 - "(a) "appropriate Form" means a Form prescribed by the Government in this behalf;
 - (b) "Class A travel agency" means a travel agency which-
 - (i) holds appointment as agent from the national airlines of Bangladesh and also from at least two foreign airlines with authority to quote air fares, make reservation, issue tickets, national and international handling of tours and do such other related acts and perform such other functions on behalf of its appointing carriers; and
 - (ii) transacts business of Taka 45 lakhs or more in a year";
 - (c) "Class B travel agency" means a travel agency which is not a Class A travel agency;
 - (d) "Ordinance" means the Bangladesh Travel Agencies (Registration and Control) Ordinance, 1977 (XLVIII of 1977); and
 - (e) "Registration Certificate" means a Registration Certificate or a provisional Registration Certificate issued under these rules,";
 - (2) in rule 3,—
 - (a) in sub-rule (1), for the word and letter "Form 'A'" the words "appropriate Form" shall be substituted;
 - (b) for sub-rule (2) the following shall be substituted, namely:-
 - "(2) Each application shall accompany a treasury chalan showing a deposit of Taka one hundred under the Head "Fees for Registration and Renewal of Travel Agencies in Bangladesh—D-Miscellaneous XLVI-Miscellaneous" and a certificate from a schedule bank showing a deposit of Taka 3 lakhs for initial capital to carry on business of travel agency."; and
 - (c) in sub-rule (3), for the words, figure and bracket "under sub-rule (1)" the words, figure and brackets "in accordance with sub-rules (1) and (2)" shall be substituted;

- (3) in rule 4, in sub-rule (2), for the words "Taka one thousand" the words, letters and figures "Taka 5 thousand for Class 'A' travel agency and Taka 2500 for Class 'B' travel agency" shall be substituted;
- (4) in rule 5,-
 - (a) in sub-rule (1), for the words and figure "in Form 'B'" the words "in appropriate Form" shall be substituted;
 - (b) in sub-rule (2), for the words "A Registration Certificate" the words "Subject to rule 5A, a Registration Certificate" shall be substituted;
- (5) after rule 5, the following new rules shall be inserted, namely:-
 - "5A. Provisional Registration Certificate, etc.-
 - Notwithstanding anything contained in rule 5, a Registration Certificate for Class B travel agency may be issued provisionally for a period of one year.
 - (2) A Class B travel agency with provisional Registration Certificate shall be required to transact business of a minimum Taka 30 lakhs within a year from the date of issue of the Certificate for the purpose of its entitlement for a regular Registration Certificate of the Class 'B'.
 - (3) The Registration Authority, if satisfied on the basis of submission of reasons, may extend the provisional Registration Certificate, on payment of fee specified in rule 6, for a further period of one year and if the travel agency fails to comply with the requirements of sub-rule (2), the validity of the provisional Registration Certificate shall automatically expire on the expiry of the extended period.
 - 5B. Office premises, staff, etc.—The Registration Authority shall refuse an application submitted under rules 3 and 6 if, after enquiry it reveals that, the office premises and staff pattern of the travel agency and the facilities provided by it do not conform to the requirements as the Government may, from time to time, issue by instruction.";
- (6) in rule 6,-
 - (a) in sub-rule (1),-
 - (i) for the words "Taka five hundred" the words, figures and letters "Taka 2500 for Class A travel agency and Taka 1000 for Class B travel agency" shall be substituted; and
 - (ii) for the word and letter "Form 'A'" the words "appropriate Form" shall be substituted;
 - (b) in sub-rule (2), for the full-stop at the end a colon shall be substituted and thereafter the following proviso shall be added, namely:—
 - "Provided that if the travel agency is a limited company, the application shall be accompanied by an audit report of the preceding working year audited by a Chartered Accountant";
 - (c) in sub-rule (3), for the word and letter "Form 'B'" the words "appropriate Form" shall be substituted;

- (7) in rule 10,—
- (a) in sub-rule (1), for clause (e) the following shall be substituted, namely:
 - "(e) if the travel agency conducts business with an unregistered travel agency; or
 - (f) if the travel agency does not maintain a Register of Travel Agent in such manner as the Registration Authority directs; or
 - (g) if the travel agency does not maintain for inspection by the Registration Authority or an officer authorised by him, a statement showing the names of persons engaged in the travel agency, the nature of services rendered by such persons, their country of origin and addresses with length of their service in the travel agency, the payment made to such person as remuneration or fees, etc.; or
 - (h) if the travel agency is found to have not acted according to the instructions issued by the Government under rule 5B; or
 - (i) for any other reasons as the Government or the Registration Authority may specify in this behalf."; and
 - (b) in sub-rule (3), for the full-stop at the end a colon shall be substituted and thereafter the following proviso shall be added, namely:—

"Provided that the Government may, on receipt of an application from the aggrieved party, review the case."

NOTIFICATION

Dacca, the 5th February 1982

No. DGP&MI-854/81.—In exercise of the powers conferred by clause 4 of the Essential Commodities Control Order, 1981, I, Shafiullah Khan, Director General of Prices and Market Intelligence, Government of the People's Republic

of Bangladesh, hereby refix the ex-distribution centre wholesale price of cement imported by Trading Corporation of Bangladesh and locally produced by BMEDC's factories for the distribution centres at Chhatak, Chittagong, Dacca, Khulna, Barisal, Ishurdi and Santahar/Saidpur at Tk. 97.00 (Taka ninety-seven) only per bag with immediate effect. In case of cement imported by TCB and packed in craft paper bag, an additional amount of Tk. 1.00 per bag may be realised over the ex-distribution centre wholesale price.

Deputy Commissioners/Subdivisional Officers will fix the maximum retail price for the respective areas taking into account the ex-distribution centre price, dealers' commission of Tk. 3.50 per bag and actual transportation and handling charges, etc., subject to a maximum of Tk. 3-50 per bag within a radius of 10 miles from the distribution centre so as to keep the maximum retail price at a level not exceeding Tk, 104.00 (Taka One Hundred Four) per bag for locally produced cement packed in gunny bag. The maximum retail price of cement at the areas beyond 10 (ten) miles should be fixed by the Deputy Commissioners/ Subdivisional Officers and the price so fixed will remain in force till such time as the price fixed under this notification is revised by this Office and, therefore, no consignment-wise price fixation of the cement by the Deputy Commissioners/ Subdivisional Officers is required. In case of cement sold in craft paper bag where additional amount of Tk. 1.00 per bag has been realised at the distribution centre, the dealers also may realise an additional amount of Tk. 1.00 per bag over the maximum retail price of Tk. 104-00 (Taka One Hundred Four only.

The maximum retail price for areas beyond the radius of 10 miles will consist of ex-distribution centre price, dealers' commission of Tk. 3.50 per bag and actual transportation and handling cost from the nearest (in terms of transport cost) distribution centre.

The maximum retail price of cement to be imported by the Private Importers will be fixed by Deputy Commissioners/Subdivisional Officers at a level not exceeding the maximum retail price for cement imported by TCB for that areas.

The Public Sector agencies and bulk-users in the Private Sectors will lift cement direct from BMEDC factories at Chhatak and Chittagong and TCB godown at Chittagong and Khulna at the uniform wholesale price fixed for the distribution centres.

The dealers will receive delivery of cement from the nearest distribution centre (in terms of transport cost).
