

#### NOTIFICATION

Whereas the Special Judge, Dacca Division, Dacca, has reason to believe that accused (1) Shamim Haider, son of Danish Mohammad of XI-C/3/8/14, Mirpur, Dacca, (2) Mostaque Ahmed, son of late Moin Sarder of XI-C/11/17/10, Mirpur, Dacca, who are accused in Special Case No. 84/79 pending in this Court, have absconded or concealing themselves so that they cannot be arrested and produced before this Court for trial and they are required for the purpose of trial;
