No. S.R.O. 73-L/81/624/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to make the following further amendments in this Ministry's Notification No. S.R.O. 132/D/Cus/74, dated the 14th March, 1974, namely:—

In the aforesaid Notification,—

- (1) in the first paragraph, in sub-paragraph (iii), for the words "instructions of the Board" the words and comma "advice of the Joint Collector of Customs and Excise. Dacca" shall be substituted; and
- (2) in the Table, in column (3),—
 - (a) against serial No. 1,—
 - (i) for the letters "F.O.B." the letters "C and F" shall be substituted; and
 - (ii) for the figure "500.00" the figure "600.00" shall be substituted; and

(b) against serial No. 2,—

- (i) for the letters "F.O.B." the letters "C and F" shall be *substituted*;
and
- (ii) for the figure "600·00" the figure "720·00" shall be *substituted*.

No. S.R.O. 74-L/81/625/Cus.—In exercise of the powers conferred by section 219 of the Customs Act, 1969 (IV of 1969), the National Board of Revenue is pleased to make the following further amendments in the Privileged Persons' Baggage Rules, 1974, namely:—

In the aforesaid Rules,—

- (1) in rule 3, in sub-rule (1),—
- (a) in clause (b) for the letters "F. O. B." occurring twice the letters "C and F" shall be *substituted* in both the places;
- (b) for the figures "500·00" and "600·00" the figures "600·00" and "720·00" shall respectively be *substituted*;
- (2) in rule 4, in sub-rule (1),—
- (a) for the word "Board" occurring for the first and second times, the words and comma "Joint Collector of Customs and Excise, Dacca" shall be *substituted* in both the places; and
- (b) for the word "direct" the word "request" shall be *substituted*; and
- (3) in rule 5,—
- (a) in sub-rule (1), for the word "Board" occurring for the first time, the words and comma "Joint Collector of Customs and Excise, Dacca" shall be *substituted*;
- (b) in sub-rule (1a), for the word "Board" the words and comma "Joint Collector of Customs and Excise, Dacca" shall be *substituted*;

- (c) in sub-rule (2), for the word "Board" occurring for the first and second times, the words and comma "Joint Collector of Customs and Excise, Dacca" shall be *substituted*.
