No. S.R.O. 83-L/81/628/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and in supersession of this Ministry's Notification No. S.R.O. 386-L/80/595/Cus., dated the 10th November, 1980, the Government is pleased to exempt coloured television receivers falling under sub-head 'B' of Tariff Heading No. 85.15 of the First Schedule to the said Act from so much of the customs duty leviable thereon as is in excess of 60% ad valorem.

In the aforesaid Notification, in the Table, against Tariff Heading No. 44.17 in column (1), in column (3), for the figure and words "50% ad val." the figure and words "15% ad val." shall be substituted.

### NOTIFICATION

### Dacca, the 19th March, 1981

No. S.R.O. 86-L/81.—In exercise of the powers conferred by the proviso to Article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service Commission as required by clause (2) of article 140 of that Constitution, is pleased to make the following rules, namely:—

THE ADMINISTRATIVE OFFICER AND ASSISTANT ACCOUNTS OFFICER (CUSTOMS AND EXCISE DEPARTMENTS) RECRUITMENT RULES, 1980.

- Short title.—These rules may be called the Administrative Officer and Assistant Accounts Officer (Customs and Excise Departments) Recruitment Rules, 1980.
- 2. Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
  - (a) "appointing authority" means the Government and includes any officer authorised by the Government to make appointment to a specified post or class of such posts;
  - (b) "Commission" means the Bangladesh Public Service Commission;
  - (c) "Customs and Excise Departments" means the departments under the charges of Collectors of Customs and Excise, the Collector of Customs and Excise (Appeal) and the Director of Customs Intelligence and Investigation;
  - (d) "probationer" means a person appointed on probation to a specified post;
  - (e) "requisite qualification", in relation to a specified post, means the qualification laid down in the Schedule in relation to that post;
  - (f) "Schedule" means the Schedule annexed to these rules; and
  - (g) "specified post" means a post specified in the Schedule.

- Method of recruitment.—(1) Subject to the provisions of the Schedule, appointment to a specified post shall be made by promotion on the recommendation of the Commission.
- (2) No person shall be appointed to a specified post unless he has the requisite qualification.
- 4. Probation.—(1) Persons selected for appointment to a specified post against a substantive vacancy shall be appointed on probation for a period of one year from the date of such appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

- (2) Where, during the period of probation of a probationer, the appointing authority is of opinion that the conduct and work of the probationer is unsatisfactory or that he is not likely to become efficient, it may, before the expiry of that period, revert him to the post from which he was promoted.
- (3) After the completion of the period of probation including the extended period, if any, the appointing authority,—
  - (a) if it is satisfied that the conduct and work of the probationer has been satisfactory, shall, subject to the provisions of sub-rule (4), confirm him; and
  - (b) if it is of opinion that the conduct and work of the probationer during that period was not satisfactory, may revert him to the post from which he was promoted.
- (4) A probationer shall not be confirmed in a specified post until he has passed such examination and undergone such training as the Government may, from time to time, directs.

### NOTIFICATIONS

### Dacca, the 21st March, 1981

No. S.R.O. 87-L/81/LIWVI/7(15)/80.—In exercise of the powers conferred by section 5 of the Factories Act, 1965 (E. P. Act IV of 1965), the Government is pleased to exempt the Bangladesh Tobacco Company Limited from the provisions of sections 50, 51, 53, 54 and 55 of the said Act for a period of six months.

No. S.R.O. 88-L/81/LIWVI/7(15)/80.—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E. P. Act VII of 1965), the Government is pleased to suspend the operation of the provisions of sections 4, 8, 10 and 11 of the said Act in respect of the Bangladesh Tobacco Company Limited for a period of six months, subject to the conditions that—

- (a) the weekly holidays to be lost during the aforesaid period shall be compensated by equal number of such holidays as soon as the circumstances permit; and
- (b) the daily and weekly hours of work during that period shall not exceed 10 and 70 hours respectively.

### MINISTRY OF CIVIL AVIATION AND TOURISM Civil Aviation Section I

### NOTIFICATION

### Dacca, the 21st March, 1981

No. S.R.O. 89-L/81.—The following draft of certain further amendments to the Aircraft Rules, 1937, which it is proposed to make in exercise of the powers conferred by section 5 of the Civil Aviation Ordinance, 1960 (XXXII of 1960), is hereby published as required by sub-section (2) of section 15 of the said Ordinance for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after a period of three weeks from the date of publication of this Notification in the official Gazette.

Any objection or suggestion which may be received from any person with respect to the said draft before the expiry of the aforesaid period will be duly considered by the Government.

### Draft Amendments

In the aforesaid Rules,

(1) for rule 81A the following shall be substituted, namely:-

"81A. Fees for the use of Airport, etc.—(1) Every passenger embarking a scheduled or non-scheduled aircraft at an airport or aerodrome shall

pay a fee for the use of, and for services provided at, such airport or aerodrome at the following rates, namely:—

Tk.

- (a) where the destination is outside Bangladesh .. 100.00
- (b) where the destination is within Bangladesh ... 10.00

Provided that the provisions of sub-rule (1) shall not apply to the following passengers, namely:—

- (a) Heads of States and Governments and their entourage;
- (b) Ministers and high dignitaries of foreign countries visiting Bangladesh as state guests;
- (c) transit passengers leaving Bangladesh by the same aircraft boarding which they entered the country or by the next available flight by which they have to reach their destination provided a scheduled night stop is not involved;
- (d) children under two years of age.
  - (2) No person in-charge of an aircraft shall allow any passenger to whom sub-rule (1) applies to board the aircraft unless such passenger has paid the fee payable under the sub-rule.
  - (3) The fee payable by a passenger under sub-rule (1) shall be collected in cash or by affixing special stamp on the air ticket.

## MINISTRY OF COMMERCE THE INSTITUTE OF CHARTERED ACCOUNTANTS OF BANGLADESH NOTIFICATION

### Dacca, the 21st March, 1981

No. S.R.O. 90-L/81.—In exercise of the powers conferred by clause (1) of Article 28 of the Bangladesh Chartered Accountants Order, 1973 (P. O. No. 2 of 1973), the Council of the Institute of Chartered Accountants of Bangladesh, with the approval of the Government, is pleased to make the following further amendments in the Bangladesh Chartered Accountants Bye-laws, 1973, the same having been previously published as required by clause (3) of that Article, namely:—

In the aforesaid Bye-laws,-

- (1) in bye-law 68, in clause (c), for sub-clause (iii) the following shall be substituted, namely:—
  - "(iii) is at least a second class graduate of a recognised University having secured—
    - (a) at least one first division either in the Secondary School Certificate or Higher Secondary Certificate Examination of a recognised Board; or

- (b) at least two second divisions in the Secondary School Certificate and Higher Secondary Certificate Examinations of a recognised Board; or":
- (2) in bye-law 80, in paragraph (1),-
  - (a) in clause (a), for the colon at the end the semi-colon and the word "; and" shall be substituted;
  - (b) in clause (b), for the colon at the end the semi-colon and the word ": or" shall be substituted and thereafter the following new clause
    - (c) shall be added, namely :-
    - "(c) he has already completed service as an articled clerk, outside Bangladesh, with a member of the Institute of Chartered Accountants in England and Wales entitled to train, under the rules of that Institute, articled clerks and has produced documentary evidence to that effect; "; and
  - (c) the fifth proviso shall be omitted;
- (3) in bye-law 90, in paragraph (2), in the second proviso, the words, figures and brackets "before completing six months' service as an articled student as required under the fifth proviso to paragraph (1) of bye-law 80" shall be omitted; and .
- (4) in bye-law 93, in paragraph (2), in the second proviso, the words, figures and brackets "before completing six months' service as an articled student as required under the fifth proviso to paragraph (1) of bye-law 80" shall be omitted.

### NOTIFICATION

### Dacca, the 21st March, 1981

No. S.R.O. 91-L/81-Sec-1/6P-9/74/36-E .- In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service Commission as required by clause (2) of article 140 of that Constitution, is pleased to make the following rules, namely:-

THE JOINT ADMINISTRATIVE OFFICER AND THE ASSISTANT ADMINISTRATIVE OFFICER (PUBLIC WORKS DEPARTMENT) RECRUITMENT RULES, 1980.

1. Short title.—These rules may be called the Joint Administrative Officer and the Assistant Administrative Officer (Public Works Department) Recruitment Rules, 1980.

- 2. Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
  - (a) "appointing authority" means the Government and includes, in relation to a specified post, any officer authorised by the Government to make appointment to such post;
  - (b) "Commission" means the Bangladesh Public Service Commission;
  - (c) "probationer" means a person appointed on probation to a specified post;
  - (d) "recognised University" means a University established by or under any law for the time being in force and includes any other University declared by the Government, after consultation with the Commission, to be a recognised University for the purpose of these rules;
  - (e) "requisite qualification", in relation to a specified post, means the qualification laid down in the Schedule in relation to that post;
  - (f) "Schedule" means the Schedule annexed to these rules; and
  - (g) "specified post" means a post specified in the Schedule.
- 3. Procedure for recruitment.—(1) Subject to the provisions of the Schedule and instructions relating to reservation for the purpose of clause (3) of article 29 of the Constitution of the People's Republic of Bangladesh appointment to a specified post shall be made—
  - (a) by direct recruitment; or
  - (b) by promotion.
- (2) No person shall be appointed to a specified post unless he has the requisite qualification and, in the case of direct recruitment, he is also within the age limit laid down in the Schedule for that post:

Provided that, the upper limit of age may be relaxed in the case of a person who has already been appointed to a specified post on ad hoc basis, by such period as he may have been holding the post continuously as an ad hoc appointee.

- 4. Appointment by direct recruitment.—(1) No appointment to a specified post by direct recruitment shall be made except upon the recommendation of the Commission.
- (2) No person shall be eligible for appointment to a specified post by direct recruitment, if he-
  - (a) is not a citizen of, or a permanent resident of, Bangladesh:

    Provided that this clause shall not apply in the case of a person who is already in the service of the Republic;
  - (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.
- (3) No appointment to a specified post by direct recruitment shall be made, until—
  - (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Director of Health Services to be medically fit, for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the specified post; and

- (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the service of the Republic.
- (4) No person shall be recommended for appointment to a specified post, unless—
  - (a) he applied in such form, accompanied by such fee and before such date as was notified by the Commission while inviting applications for the specified post; and
  - (b) in the case of a person already in Government service or in the service of a local authority, he applied through his official superior.
- 5. Appointment by promotion.—(1) No appointment by promotion to a specified post shall be made except upon the recommendation of the Commission.
- (2) A person shall not be eligible for appointment by promotion to a specified post if he has unsatisfactory records of service,
- 6. Probation.—(1) A person selected for appointment to a specified post against a substantive vacancy shall be appointed on probation—
  - (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
  - (b) in the case of promotion, for a period of one year from the date of such appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

- (2) Where, during the period of probation of a probationer, the appointing authority is of opinion that the conduct and work of the probationer is unsatisfactory or that he is not likely to become efficient, it may, before the expiry of that period,—
  - (a) in the case of direct recruitment, terminate his service; and
  - (b) in the case of promotion, revert him to the post from which he was promoted.
- (3) After the completion of the period of probation including the extended period, if any, the appointing authority,—
  - (a) if it is satisfied that the conduct and work of the probationer during the period of probation has been satisfactory, shall, subject to the provisions of sub-rule (4), confirm him; and
  - (b) if it is opinion that the conduct and work of the probationer during that period was not satisfactory, may,—
    - (i) in the case of direct recruitment, terminate his service; and
    - (ii) in the case of promotion, revert him to the post from which he was promoted.
- (4) A probationer shall not be confirmed to a specified post until he has passed such examination and has undergone such training as the Government may, from time to time; prescribe by order.
