PROCLAMATION

Whereas it has been made to appear before me that (1) Fatique *alias* Sajjad, son of Bhanu, Vill. Darusha, P.S. Paba, Dist. Rajshahi, (2) Md. Maniruddin, son of late Hamid Mondal, Vill. Golai, P.S. Godagari, Dist. Rajshahi who are accused persons in Special Powers Act Case No. 102/77, arising out of Paba P.S. Case No. 18, dated the 13th April 1975, G.R. Case No. 444/75, u/ss. 395/397, B.P.C. and Special Powers Act, is required for the purpose of trial before the Special Tribunal Judge, Rajshahi;

And whereas this Court has reason to believe that the said accused persons (1) Fatique *alias* Sajjad, son of Bhanu of Vill. Darusha, P.S. Paba, Dist. Rajshahi, (2) Md. Maniruddin, son of late Hamid Mondal of Vill. Golai, P.S. Godagari, Dist. Rajshahi are absconding to avoid appearance or arrest for the said purpose;

Therefore, in exercise of the powers conferred by section 27(6) of the Special Powers Act, 1974 the accused persons named (1) Fatique *alias* Sajjad, son of Bhanu of village Darusha, P.S. Paba, Dist. Rajshahi, (2) Md. Maniruddin, son of late Hamid Mondal, village Golai, P.S. Godagari, Dist. Rajshahi, are directed to appear before the said Tribunal at Rajshahi within 14 days of publication of the same, failing which they will be tried *in absentia*:
