NOTIFICATION

Dacca, the 5th April, 1982

No. S.R.O. 106-L/82/3A-12/D-12/79.—In exercise of the powers conferred by section 203 of the Air Force Act, 1953 (VI of 1953), and in supersession of all other regulations, orders and instructions issued in this behalf, the Government is pleased to make the following regulations, namely:—

1. (i) These regulations may be called the Bangladesh Air Force Airmen (Training of Photographers) Regulations, 1982.
(ii) They shall come into force at once.
2. (i) To achieve and maintain a high standard of photography skill in the Bangladesh Air Force, all Airmen up to the rank of Sergeant of the photography trade shall be given regular practical training in the Base/Unit.
(ii) Every airman shall be required to produce at least 5 negatives and 20 prints of various sizes per month and the completed jobs are to be retained and produced before the Staff Officers for inspection on the visit to the Base/Unit.
3. The Officer-in-Charge, Photo Flight, shall raise the demand Form No. 10014 and sign the job sheet Form No. 2046 when receiving the negatives and prints.

NOTIFICATION

Dacca, the 5th April, 1982

No. S.R.O. 107-L/82.—In exercise of the powers conferred by Article 17 of the Bangladesh Passport Order, 1973 (P.O. No. 9 of 1973), the Government is pleased to make the following further amendments in the Bangladesh Passport Rules, 1974, namely :—

In the aforesaid Rules,—

- (1) in rule 3, in sub-rule (1), for the words and comma "Director, Immigration and Passports" the words and comma "Director-General, Immigration and Passports" shall be *substituted*;
- (2) in rule 10, for the words "Director of Immigration and Passports" occurring twice the words and comma "Director-General, Immigration and Passports" shall be *substituted* in both the places ; and
- (3) in Schedule 1,—
 - (a) before the first entry "Deputy Director of Immigration and Passports" in column 1 and the entries relating thereto in columns 2 and 3, the following new entries shall be *inserted*, namely :—

"Director of Immigration and Passports.	International Special Passports and Travel documents.	Whole of Bangladesh"; and

- (b) *in place of* the existing fourth entry in column 1, the entry "Deputy Commissioners other than Deputy Commissioners of Dacca, Sylhet, Chittagong, Mymensingh, Barisal, Comilla, Rajshahi, Khulna and Rangpur." shall be *substituted*.
