NOTIFICATION

Dhaka, the 28th March 1983

No. S.R.O. 112-L/83/BA3P-39/80(1)/243.—In exercise of the powers conferred by Article 19 of the Bangladesh Rifles Order, 1972 (P.O.No. 148 of 1972), the Government is pleased to make the following further amendments in the Bangladesh Rifles Regulations, 1922, namely:—

In the aforeseid Regulations,-

- (1) after rule 112, the following new rules shall be inserted, namely:-
 - 112A. Every sepoy, non-commissioned officer and junior commissioned officer, while serving within the local limits of the districts of Chittagong Hill Tracts and Bandarban, shall, in addition to the articles admissible under rule 112, be entitled to receive one pair of knaki trousers and one khaki shirt.
 - 112B. Every member of the IWT Staff (Civil) of the Bangladesh Rifles shall be provided with the following articles of clothing, namely—
 - (1) Khaki Trouser ..

.. 2 pairs.

(2) Khaki Shirt with full sleeves
