No. S.R.O. 116-L/82/700/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following amendment in this Ministry's notification No. S. R. O. 227-L/81/654/Cus., dated the 29th June, 1981, namely:—

In the aforesaid Notification, in the Table before Tariff Heading 73·31 in column (1) and the entries relating thereto, the following new Tariff Heading No. 39·07 and the entries relating thereto shall be *inserted*, namely:

“39·07 Bobbins, silver cans and parts, accessories and components thereof.”

In the aforesaid Notification, in the Table, for Tariff Heading Nos. 15.07 and 15.08 in column (1) and the entries relating thereto in columns (2) and (3), the following shall be *substituted*, namely:

“15.07 (i) Soyabean oil, cotton seed oil, ground nut oil, sunflower seed oil, rape oil, mustard oil, linseed oil, coconut (copra) oil and palm kernel oil but excluding crude degummed soyabean oil and crude palm oil 25% *ad val.*

(ii) Crude degummed soyabean oil 20% *ad val.*

(iii) Crude palm oil 35% *ad val.*
