NOTIFICATION

Dacca, the 12th April 1982

No. SRO-119-L/82/MF/S-7/1F-29/77(Pt.)/179.—In exercise of the powers conferred by sub-clause (4) of clause 7 of the Foodstuffs Price Control and Anti-Hoarding Order, 1953, and in supersession of this Division's notification No. S.R.O. 317-L/77/740-MF/S-7/1F-29/77, dated the 15th October, 1977, the Government is pleased to direct that, subject to the provisions specified in this Notification, no wholesaler or retailer, outside the five-mile border-belt of Bangladesh, shall keep in his possession or under his control rice or paddy in excess of—

- (i) five thousand maunds in the case of a wholesaler; and
- (ii) two hundred and fifty maunds in the case of a retailer.

*Explanation.*—In case the stock in the possession of any wholesaler or retailer consists partly of rice and partly of paddy, the total quantity of rice and paddy shall constitute the total stock held by him.
