Dacca, the 20th May, 1980

No. S.R.O. 132-L/80-LIWVI/8(13)/78.—In exercise of the powers conferred by section 5 of the Factories Act, 1965 (E.P. Act IV of 1965), the Government is pleased to exempt the Bangladesh Government Press from the provisions of sections 50 and 51 of the said Act for a period of six months.

No. S.R.O. 133-L/80-LIWVI/11(23)/78.—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E.P. Act VII of 1965), the Government is pleased to suspend the operation of the provisions of sections 4, 8, 10 and 11 of the said Act in respect of the Bangladesh Tobacco Company Limited for a period of six months, subject to the conditions that—

- (a) the weekly holidays to be lost during the aforesaid period shall be compensated by equal number of such holidays as soon as the circumstances permit; and
- (b) the daily and weekly hours of work during that period shall not exceed 10 and 70 hours respectively.

No. S.R.O. 135-L/80-LIWVI/11(24)/78.—In exercise of the powers conferred by section 5 of the Factories Act, 1965 (E.P. Act IV of 1965), the Government is pleased to exempt the Glaxo Bangladesh Limited from the provisions of sections 50 and 53 of the said Act for a period of six months.
