

No. S.R.O. 130-L/82.—In exercise of the powers conferred by sub-section (1) of section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to make the following further amendment in this Division's notification No. S.R.O. 176-L/81/ST-2, dated the 6th June 1981, namely:—

In the aforesaid Notification, in the entries against item No. 61, for the full-stop at the end a colon shall be substituted and thereafter the following proviso shal be inserted, namely:

"Provided that in the case of the said raw materials, the exemption under this Notification shall apply to such manufacturers only as are approved by the National Board of Revenue for this purpose."

### IN THE FIFTH COURT OF THE ADDITIONAL SESSIONS JUDGE AND SPECIAL TRIBUNAL, MYMENSINGH

Special Powers Act Case No. 331/77 arising out of Pakundia P.S. Case No. 5, dated 26th May 1974, under section 19 A and (f) of the Arms Act read with Special Powers Act, 1974.

### NOTIFICATION

Whereas Angur, son of Jamaluddin alias Kati Mia of village Saluadi, P.S. Pakundia, Dist. Mymensingh, is an accused in the abovementioned case;

And whereas this Court has reason to believe that the said accused is absconding himself to avoid appearance for his trial;

Now, therefore, I direct the said (1) Makbul, (2) Kashem and (3) Hachunia to appear before this Tribunal on 22nd June 1982 or within 30 days of publication of the Notification in the official Gazette, whichever is later in the abovementioned case, failing which they will be tried in absentia.
