No. S.R.O. 149-L/80/519/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to exempt fishing trawlers falling under Heading No. 89·01 of the First Schedule to the Tariff Act, 1934 (XXXII of 1934), from so much of customs-duties leviable thereon as are in excess of 2½% ad valorem, provided that the importer, at the time of clearence of the trawler, furnishes a certificate from the Director General, Department of Industries, in the form appended in Annex I and an undertaking in the form appended in Annex II stating that he shall export not less than 80% of the fish caught by use of the trawler and binding himself to pay the balance of the customs-duties leviable thereon had this concession not been allowed if it is proved on the certification of the Collector of Customs of the territorial jurisdiction that the importer has failed to export at least 80% of the catch in every year after the fishing trawler go into operation for catching
