No. S. R. O. 154-L/81/LIWVI/6(10)/80.—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E.P. Act VII of 1965), the Government is pleased to suspend the operation of the provisions of sections 4, 8 and 11 of the said Act in respect of the Ashuganj Fertilizer and Chemical, Co. Limited, Ashuganj, in the district of Comilla, for a period of one year, subject to the following conditions, namely:—

- (a) the workers required to work overtime shall be paid wages at double the ordinary rates of wages for working beyond the normal working period of nine hours a day and forty-eight hours a week.
- (b) the workers deprived of weekly holidays shall be allowed compensatory weekly holidays within the period of operation of the Notification.

No. S. R. O. 155-L/81/LIWVI/6(10)/80.—In exercise of the powers conferred by section 5 of the Factories Act, 1965 (E. P. Act IV of 1965), the Government is pleased to exempt the Ashuganj Fertilizer and Chemical Company Limited, Ashuganj in the district of Comilla from the provisions of sections 50, 51, 53, 54 and 55 of the said Act for a period of six months.
