Dacca, the 23rd May 1981

No. S.R.O.157-L/81.—Whereas the Government, having considered it to be expedient, directed by Order No. 1(1)/76-T.O.(Pt.), dated the 31st March, 1981, the Federation of Bangladesh Chambers of Commerce and Industry to amend its Articles of Association in order to make provision for separate elections of the representatives of Chambers and Associations to the Executive Committee constituted under Article 14 of the said Articles of Association by the votes of Chamber group voters and Association, group voters respectively within 30 days from the date of the said Order;

And whereas the Federation of Bangladesh Chambers of Commerce and Industry has failed to comply with the aforesaid direction within the aforesaid period:

Now, therefore, in exercise of the powers conferred by sub-section (2) of section 8 of the Trade Organisations Ordinance, 1961 (XLV of 1961), the Government is pleased to make the following amendments in the Articles of Association of the Federation of Bangladesh Chambers of Commerce and Industry, namely:—

In the aforesaid Articles of Association, after Article 14, the following new Article shall be inserted, namely:—

"14A. The President, the Vice-President and other Members as are required to be elected from the representatives of Chambers and Associations under Article 14 shall be elected on the basis of separate elections, that is, the Chamber group voters and the Association group voters voting for their respective candidates only."

In the Employment (Record of Services) Rules, 1957, for rule 6 the following shall be substituted, namely:—

"6. Manufacture of Service Book.—All employers may manufacture or cause to be manufactured Service Books in accordance with the specification laid down in rules 3 and 4 in order to enable them to provide the Service Books to their employees as required by rule 5.".
