No. S.R.O. 162-L/81.—In exercise of the powers conferred by the Post Office Act, 1898 (VI of 1898), the Government is pleased to make the following further amendments in the Post Office Rules, 1961, namely—

In the aforesaid Rules, for rule 7 the following shall be substituted, namely:-

"7. The following rates of postage shall be chargeable on postal articles when the postage is prepaid:

MD. KHAIRUZZAMAN

Whereas it has been made to appear to me that the accused Md. Khairuzzaman, son of late Shariotullah of Godwan Road, Gaibandha Town, District Rangpur, is required for the purpose of trial in the court of Senior Special Judge, Bogra, under section 409 B.P.C. and section 5/2 of Act II/47 in connection with Special Case No. 4/81, Dhunat P.S. Case No. 5(7)79, D.A.B.G.R. 32/79;

And whereas this Court has reason to believe that the said accused person is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred upon me by section 6(IA) of Criminal Law Amendment Act, 1958 as amended by Ordinance VI of 1978, I do hereby direct the said accused person to appear in this Court within 30 days from the date of publication of this Notification, failing which he shall be tried in absentia.
