- (1) against entry (a), for the figure "0.95" the figure "0.75" shall be substituted; and
- (2) against entry (b), for the figure "1.45" the figure "1.10" shall be substituted.

No. S.R.O. 169-L/81.—In exercise of the powers conferred by section 20 of the Jute Ordinance, 1962 (LXXIV of 1962), the Government is pleased to make the following further amendments in the Jute (Licensing and Enforcement) Rules, 1964, namely:—

In the aforesaid Rules,-

- 1. in rule 2,-
- (a) after clause (c), the following new clause shall be inserted, namely:-
 - "(cc) "dealer of jute manufactures" means a dealer who deals in jute manufactures but does not include an occupier of a jute mill;"; and
 - (b) in clause] (h), the words "or deals in jute manufactures other than occupier of a jute mill" shall be omitted;

- 2. in rule 5, in clause (b), after entry (vii) and the entries relating thereto in the first and second columns, the following shall be substituted, namely:—
 - "(viii) Dealer of jute manufactures.—1 As per provisions of the Ordinance and the Rules.";
- in rule 7, in clause (f), after the words and comma "an exporter of jute or jute manufactures," the letter, words and comma "a dealer of jute manufactures," shall be substituted;
- 4. For Schedule I the following shall be substituted, namely:-

"SCHEDULE I

(see rule 3)

The Schedule of fees

(1) Occupier of jute mill

- (a) Taka 5,000 for every 250 looms or fraction thereof of each mill;
 - (b) Taka 3,000 for every 700 spindles or fraction thereof of each spinning mill;
 - (c) Taka 1,000 for every 10-inches or of lesser width 20 looms or fraction thereof of each mill:

Provided that no separate licence for the godowns and presses, if any, situated within the mill premises shall be required to be obtained.

(2) Manufacturer

: Taka 2,500.

(3) Dealer of jute manufactures: Taka 1,000 for each business station.

(4) Exporter

: Taka 7,500.

(5) Pucca baler

: Taka 3,000 for each business station.

(6) Kutcha baler

: Taka 1,000 for each business station.

(7) Aratdar

: Taka 500 for each business station.

(8) Bepari, Faria and Paiker

: (a) Taka 100 each for those who have no business establishment and no godown licence at any place;

(b) Taka 500 each for those who have godown licence at any place.

(9) Dalal : Taka 500.

(10) Internal broker : Taka 1,000.

(11) Export broker : Taka 7,500.

(12) Occupier of Pucca Press : Taka 7,500 for each press.

(13) Occupier of Kutcha Press: Taka 1,500 for each press, (Hand-driven)

(14) Occupier of Kutcha Press: Taka 3,500 for each press. (Engine-driven).

(15) Occupier of godown : Taka 150 for every 2000 square feet of floor area or a fraction thereof of each godown (used by dealers).

The above rates of fees shall be effective in respect of licences to be issued or renewed for the financial year 1981-82 and subsequent years.";

5. in Schedule 1A, against serial 1 in the second column, after the item (ii), the following shall be substituted, namely:—

"(iia) dealer of jute manufactures,";

6. in Schedule II,-

- (a) in Application Form No. JA(I), in entry (4), for the word "sale" the words "sale and purchase" shall be substituted;
- (b) in Application Form No. JA(II),-
 - (i) after the word and comma "Manufacturers," wherever occurring, the words and comma "dealer of jute manufactures," shall be substituted;
 - (ii) in entry (2), for sub-entry (a) the following shall be substituted, namely:—
 - "(a) Station of business (where he/she/they has/have established office or business establishment. If he/she/they has/have no established office or business establishment his/her/their permanent or temporary dwelling) with full postal address.";
 - (iii) for entry (4) the following shall be substituted, namely:-
 - "(4) Area of operation, if any, outside business station (such operation in the case of exporters and manufacturers being restricted to the purchase and sale of jute or jute goods in bales, in the case of pucca balers to the purchase and sale of jute in bales and in the case of dealers of jute manufactures to the purchase of jute manufactures only."; and

(c) in Application Form No. JA(VI), in paragraph (1) under heading "Authority to whom the application to be submitted (separately for each category of licence)", after the word and comma "manufacturers," the words and comma "dealers of jute manufactures," shall be inserted;

7. in Schedule III,-

- (a) in Licence Form No. JB(I), in the heading of column 3, for the word "sale" the words "sale and purchase" shall be substituted;
- (b) in Licence Form No. JB(II),-
 - (i) after the word and comma "Manufacturers," and "manufacturers," wherever occurring the words and comma "Dealers of jute manufactures" and "dealers of jute manufactures" shall respectively be substituted; and
 - (ii) for the heading of column 2A the following shall be substituted, namely:—

"Area of operation, if any, outside business station (such operation in the case of exporters and manufacturers being restricted to the purchase and sale of jute or jute goods in bales, in the case of pucca balers to the purchase and sale of jute in bales and in the case of dealers of jute manufactures to the purchase of jute manufactures only)."
