ORDER

Dhaka, the 19th May, 1983

No. S.R.O. 167-L/83/776/Cus.—In exercise of the powers conferred by clause (b) of section 21 of the Customs Act, 1969 (IV of 1969), and sub-section (2) of section 4 of the Sales Tax Ordinance, 1982 (Ord. XVIII of 1982), the National Board of Revenue is pleased to authorize the delivery without payment of the whole of the customs-duties chargeable thereon and grant exemption from the payment of the whole of the sales tax payable in respect of the raw materials, components, spares and accessories required for local manufacture of irrigation pump sets (consisting of diesel engines, pumps, couplings trolleys and those items of spares, components and accessories which are supplied with the set, as per standard practice) when imported by the Bangladesh Diesel Plants, Joydebpur, Dhaka.

2. This order shall be deemed to have come into force on the 1st day of May, 1983, and shall continue to remain in force for a period of one year from the aforesaid date, subject to the condition laid down in the Cabinet Division letter No. 10/79/ECNEC/56(6), dated the 17th May, 1980.
