NOTIFICATION

Dhaka, the 22nd May, 1983

No. S.R.O. 169-L/83.—In exercise of the powers conferred by sub-section (1) of section 3 of the Imports and Exports (Control) Act, 1950 (XXXIX of 1950), the Government is pleased to make the following further amendment in the Licences and Permits Fees Order, 1958, namely :—

In the aforesaid Order, in paragraph 3, for sub-paragraph (2), the following shall be substituted, namely :—

“(2) In the cases of imports under Wage Earners' Scheme, Baggage Rules and other imports for which no letter of credit is required to be opened, receipted treasury chalan showing the payment of fee shall be submitted to the licensing authority before the import permit or clearance permit, as the case may be, is issued. In the cases of other imports, whether against import licence or not, for which letter of credit is required to be opened, a receipted treasury chalan showing the payment of fee on the value of the letter of credit shall be submitted by the importer to the scheduled bank before retirement of import documents.”
