

No. S.R.O.171-L/83/S-1/1R-76/83/254.—The following draft of certain further amendment which the Government proposes to make in the Co-operative Societies Rules, 1942, in exercise of the powers conferred by section 140 of the Co-operative Societies Act, 1940 (Ben. Act XXI of 1940), is hereby published, as required by sub-section (1) of the said section, for information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration on or after 9th June, 1983. Any objection or suggestion with respect to the said draft which may be received by the undersigned before the date specified will be duly considered by the Government:

Draft Amendment

In the aforesaid Rules, in rule 35, in sub-rule (1), for clause (d), the following shall be substituted, namely:—

"(d) or the society which he represents has failed to pay to the society at least 75% of the loans, advances or any other kind of dues or instalments thereof repayable by him or, as the case may be, by the society which he represents;".
