- (b) Chairman, Bangladesh Road Transport Corporation.
- (c) Joint Secretary, Ministry of Railways, Roads, Highways and Road Transport (RTC).
- (d) Financial Adviser, Ministry of Railways, Roads, Highways and Road Transport.
- (e) Director (Admn. and Operation), Bangladesh Road Transport Corporation.”

THE INSTITUTE OF CHARTERED ACCOUNTANTS OF BANGLADESH

[Established under the Bangladesh Chartered Accountants Order, 1973

NOTIFICATION

Dacca, the 3rd July, 1979.

No. S.R.O. 191-L/79.—In exercise of the powers conferred by clause (1) of Article 28 of the Bangladesh Chartered Accountants Order, 1973 (P.O. No. 2 of 1973), the Council of the Institute of Chartered Accountants of Bangladesh with the approval of the Government is pleased to make the following further

amendments to the Bangladesh Chartered Accountants Bye-laws, 1973, the same having been previously published as required by clause (3) of that Article, namely:—

In the aforesaid Bye-laws,—

(1) in bye-law 2, in paragraph (3), after clause (i), the following new clause (ii) shall be inserted, namely:—

“(ii) “recognised Board” means a Board of Intermediate and Secondary Education established by or under any law for the time being in force and includes any other Board declared by the Government to be a recognised Board for the purposes of these bye-laws;”;

(2) in bye-law 68, for clause (c) the following shall be substituted, namely:—

“(c) such person—

(i) has passed the Secondary School Certificate and Higher Secondary Certificate Examinations of a recognised Board in the first Division; or

(ii) has passed the Secondary School Certificate and Higher Secondary Certificate Examinations of a recognised Board in the first division having secured at least sixty-five per cent marks in the aggregate in the said examinations; or

(iii) is at least a second class graduate of a recognised University having secured at least one first division either in the Secondary School Certificate or Higher Secondary Certificate Examination of a recognised Board; or

(iv) is at least a second class honours graduate of a recognised University; or

(v) holds at least a second class Master's degree in Arts, Commerce or Science of a recognised University; or

(vi) is at least a second class graduate of the Institute of Business Administration; or

(vii) is at least a graduate of a recognised University provided he obtains a certificate from the Institute to the effect that he has passed an examination conducted by the Institute in such subject or subjects as the Council may from time to time determine in this behalf.”;

(3) in bye-law 80,—

(a) in paragraph (1), in clause (a), after the words “from such examinations”, the words “or from such paper or papers of the Final Examination” shall be inserted; and

(b) for paragraph (2) the following shall be substituted, namely:—

“(2) A person shall not be eligible for enrolment on the Register of the Institute, except as otherwise provided in the Order or these bye-laws, unless he has produced a certificate in such form as

the Council may prescribe, from a member entitled to train articled students that he has served as an articled student with him for a continuous period of—

- (a) five and a half years if he is a person specified in sub-clauses (i) and (ii); or
- (b) three and a half years if he is a person specified in sub-clause (iii) and (vii); or
- (c) three years if he is a person specified in sub-clauses (iv), (v) and (vi), of clause (c) of bye-law 68:

Provided that a person specified in sub-clause (i) of clause (c) of bye-law 68, may, with the prior permission of the Institute and consent of his principal, pursue higher academic studies in commerce faculty in a college or University in the evening classes:

Provided further that a person specified in sub-clause (ii) of clause (c) of bye-law 68, may, with the prior permission of the Institute and consent of his principal, pursue honours or post-graduate course in commerce faculty concurrently with his service as an articled student:

Provided further that a person specified in sub-clause (ii) of clause (c) of bye-law 68, may, with the consent of his principal, attend the office of the principal on such days and at such times, as may be mutually agreed upon. The number of days, if any, such an articled student attends the office of the principal during his study in the college or University shall be treated towards the period of articleship and on completion of his honours or post-graduate course in commerce faculty, he shall be required to complete the balance period of articleship on the basis of five and a half years or three and a half years under clause (a) or clause (b) of paragraph (2) of bye-law 80, as the case may be:

Provided further that a principal shall be entitled to engage as an articled student only one such person as specified in sub-clause (ii) of clause (c) of bye-law 68 who shall be treated as an additional articled student:

Provided further that the period of articleship of five and a half years in the case of a person specified in sub-clause (i) or sub-clause (ii) of clause (c) of bye-law 68 may be reduced to three and a half years from retrospective date of registration as an articled student if—

- (a) he is a person specified in sub-clause (i) and obtains graduation in commerce faculty from a recognised University securing not below second class; or
- (b) he is a person specified in sub-clause (ii) and becomes an honours graduate or a post-graduate in commerce faculty

from a recognised University securing at least fifty-five per cent marks in the honours or post-graduate examination.”; and

- (4) after bye-law 93, the following new bye-law shall be added, namely:—

“93A. Exemption from a paper or papers of the Final Examination.—Any person who has completed service as an articled clerk with a member of the Institute of Chartered Accountants in England and Wales entitled to train articled clerks and has passed or has been exempted from the Intermediate Examination and has also passed Professional Examination I of the said Institute shall be eligible for exemption from Paper (ii), Paper (iii) and Paper (iv) of Group II of the Final Examination as contained in Section ‘B’ of Schedule ‘B’ to these bye-laws provided such a person has registered himself as student of the Institute.”.
