Dacca, the 19th June 1980

No. S.R.O. 197-L/80.—In exercise of the powers conferred by section 3 of the Control of Essential Commodities Act, 1956 (E.P. Act I of 1956), the Government is pleased to make the following further amendment in the Essential Commodities Price and Distribution Order, 1970, namely:—

In the aforesaid Order,—

(1) in clause 12, *after* the word "Director" the words "or the Controller General of Prices and Supplies" shall be *inserted*; and

(2) *for* clause 14 the following shall be *substituted*, namely:—

"14. **Power of amendment of the Schedule and exemption.**—The Director or the Controller General of Prices and Supplies may, by notification in the official Gazette, amend, alter or modify the Schedule to this Order or exempt any person or any Scheduled Article from such provision or provisions of this Order and in respect of such area or areas as he may deem fit".

(3) *after* clause 10, the following new clause shall be *inserted*, namely:—

"(10A) **Prohibition to keep Scheduled Articles without document.**—No importer, producer or dealer shall keep any Scheduled Article in his possession without any document or receipt for such Scheduled Article".
